**SENATE SUBSTITUTE AMENDMENT 2,  
TO 2001 SENATE BILL 463**

March 7, 2002 - Offered by Senators RISSER, CHVALA and MOEN.

1     **AN ACT** *to repeal* 4.001 (2) to (5), 4.004 and 4.005; *to renumber and amend*  
2         4.001 (1); *to repeal and recreate* 4.002, subchapter II of chapter 4 [precedes  
3         4.009] and subchapter III of chapter 4 [precedes 4.01]; and *to create* 4.006 and  
4         13.92 (1) (b) 3. e. of the statutes; **relating to:** legislative redistricting.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

5         **SECTION 1.** 4.001 (1) of the statutes is renumbered 4.001 and amended to read:

6         **4.001 Legislative redistricting; equal population districts established.**

7         ~~Based on the certified official results of the 1980 census of population of Wisconsin,~~  
8         ~~as received by this state from the U.S. bureau of the census on March 23, 1981, under~~  
9         ~~P.L. 94-171, the This state is divided into 33 senate districts, each composed of 3~~  
10         assembly districts. Each senate district shall be entitled to elect one member of the  
11         senate. Each assembly district shall be entitled to elect one representative to the  
12         assembly.

1           **SECTION 2.** 4.001 (2) to (5) of the statutes are repealed.

2           **SECTION 3.** 4.002 of the statutes is repealed and recreated to read:

3           **4.002 County and municipal boundaries and wards.** In this chapter,  
4 reference to any county or municipality means that county or municipality as its  
5 boundaries exist on August 1 of the year following the federal decennial census on  
6 which the districting plans described under subchs. II and III are based.

7           **SECTION 4.** 4.004 of the statutes is repealed.

8           **SECTION 5.** 4.005 of the statutes is repealed.

9           **SECTION 6.** 4.006 of the statutes is created to read:

10           **4.006 Definitions.** In this chapter:

11           **(1)** “Block” has the meaning given in s. 5.02 (1q).

12           **(2)** “Ward” means a municipal ward in effect on August 1 of the year following  
13 the federal decennial census on which the districting plans described under subchs.  
14 II and III are based.

13 **(2) MONROE COUNTY.** That part of Monroe County consisting of all of the  
14 following:

15 (a) The towns of Jefferson, Leon, and Portland.

16 (b) That part of the town of Sparta comprising wards 1, 3, and 4.

17 (c) The villages of Cashton and Melvina.

18 (d) The city of Sparta.

19 **(3) VERNON COUNTY.** That part of Vernon County consisting of all of the  
20 following:

21 (a) The towns of Bergen, Christiana, Clinton, Coon, Franklin, Genoa,  
22 Hamburg, Harmony, Jefferson, Kickapoo, Liberty, Stark, Sterling, Viroqua, Webster,  
23 and Wheatland.

24 (b) The villages of Chaseburg, Coon Valley, Genoa, La Farge, Readstown, and  
25 Stoddard.



1 (c) That part of the village of De Soto located in the county.

2 (d) The cities of Viroqua and Westby.

3 **4.97 Ninety-seventh assembly district.** All of the following territory in  
4 Waukesha County constitutes the 97th assembly district:

5 (1) That part of the town of Brookfield comprising ward 7.

6 (2) That part of the city of Waukesha comprising wards 1, 2, 3, 4, 5, 6, 7, 8, 9,  
7 10, 11, 12, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, and 32.

8 **4.98 Ninety-eighth assembly district.** All of the following territory  
9 constitutes the 98th assembly district:

10 (1) JEFFERSON COUNTY. That part of Jefferson County consisting of all of the  
11 following:

12 (a) The towns of Concord, Farmington, Palmyra, and Sullivan.

13 (b) The villages of Johnson Creek, Palmyra, and Sullivan.

14 (2) WALWORTH COUNTY. That part of Walworth County consisting of the town  
15 of La Grange.

16 (3) WAUKESHA COUNTY. That part of Waukesha County consisting of all of the  
17 following:

18 (a) The towns of Eagle, Genesee, Ottawa, and Summit.

19 (b) That part of the town of Delafield comprising wards 10 and 11.

20 (c) That part of the town of Waukesha comprising wards 1, 3, 4, 5, and 8.

21 (d) The villages of Dousman, Eagle, Oconomowoc Lake, and Wales.

22 (e) The city of Delafield.

23 (f) That part of the city of Waukesha comprising wards 33 and 36.

24 **4.99 Ninety-ninth assembly district.** All of the following territory  
25 constitutes the 99th assembly district:

1           **(1) JEFFERSON COUNTY.** That part of Jefferson County consisting of all of the  
2 following:

3           (a) The towns of Cold Spring and Hebron.

4           (b) That part of the city of Whitewater located in the county.

5           **(2) WALWORTH COUNTY.** That part of Walworth County consisting of all of the  
6 following:

7           (a) The towns of Darien, Delavan, Geneva, Linn, Richmond, Sharon, Sugar  
8 Creek, Walworth, and Whitewater.

9           (b) The villages of Darien, Fontana-on-Geneva Lake, Sharon, Walworth, and  
10 Williams Bay.

11           (c) The city of Delavan.

12           (d) That part of the city of Whitewater located in the county.

13           **SECTION 9.** 13.92 (1) (b) 3. e. of the statutes is created to read:

14           13.92 **(1)** (b) 3. e. After passage of any bill that, if enacted, would create  
15 legislative districts under ch. 4, in enrolling the bill for presentation to the governor  
16 for approval, the legislative reference bureau shall attach to the bill an appendix  
17 containing the population statistics for the legislative districts created under the bill;  
18 a statewide map of each type of legislative district created under the bill; a map of  
19 the legislative districts created under the bill that are in Milwaukee County; and, for  
20 any city, village, or town that, under the bill, is divided among 2 or more legislative  
21 districts, except a city or village located in more than one county if the district line  
22 follows the county line, a detail map illustrating the division of the city, village, or  
23 town among the legislative districts.

24           **SECTION 10. Initial applicability.**

1           (1) This act first applies, with respect to regular elections, to offices filled at the  
2           2002 general election.

3           (2) This act first applies, with respect to special or recall elections, to offices  
4           filled or contested concurrently with the 2002 general election.
