ASSEMBLY AMENDMENT 1, TO 2003 ASSEMBLY BILL 893

February 26, 2004 – Offered by JOINT LEGISLATIVE AUDIT COMMITTEE.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 14: after that line insert:

3 "SECTION 2m. 13.489 (2m) of the statutes is created to read:

13.489 (2m) APPROVAL OF CERTAIN PROJECT DESIGN CHANGES. If at any time after 4 a project is enumerated under s. 84.013 (3) or approved under s. 84.013 (6) the $\mathbf{5}$ 6 department of transportation proposes any project design changes that involve 7 upgrading any portion of the project from a highway to a freeway or expressway, 8 adding one or more traffic lanes in any direction, upgrading any intersection at grade to an interchange, or upgrading an interchange to accommodate higher-speed 9 10 traffic, the department shall, prior to implementing the proposed project design 11 changes, report the proposed project design changes, any reason for these design 12changes, and the estimated project cost attributable to these design changes, to the commission for review and approval. The commission shall review any report 13

submitted under this subsection. If, within 14 days after the date on which the report 1 $\mathbf{2}$ is submitted to the commission, no member of the commission notifies the 3 department that the commission will schedule a public hearing on the proposed 4 project design changes, the department may implement the proposed project design $\mathbf{5}$ changes as specified in the report. If, within 14 days after the date on which the 6 report is submitted to the commission, any member of the commission notifies the 7 department that the commission will schedule a public hearing on the proposed 8 project design changes, the commission shall schedule and conduct such a public 9 hearing and, within 60 days of the department's submission of the report, notify the 10 department of those proposed project design changes that the commission approves 11 or approves with modifications or notify the department that it does not approve any 12of the proposed project design changes. If, within 14 days after the date on which the 13department's report is submitted to the commission, any member of the commission 14notifies the department that the commission will schedule a public hearing on the 15proposed project design changes, the department may not implement any proposed 16 project design changes required to be submitted to the commission under this 17subsection unless the commission notifies the department under this subsection that 18 the proposed project design changes, with or without modifications, are approved.".

2. Page 4, line 12: delete "3" and substitute "6".

20 **3.** Page 4, line 23: after that line insert:

21 "SECTION 5m. 13.489 (6) of the statutes is created to read:

13.489 (6) DEPARTMENT TO MAKE INFORMATION AVAILABLE. The department of
transportation shall make all of the following information available to the public,

including making the information available at no charge on the department's
Internet site, within the following time periods:

3 (a) Subject to par. (d), any report prepared by the department for the 4 commission shall be available within 5 business days of the report's completion and 5 transmittal to the commission.

6 (b) Subject to par. (d), any materials or documents prepared by the department 7 for use at a meeting of the commission shall be available at least 5 business days prior 8 to the meeting.

9 (c) Any other information directed by the commission to be made available by 10 the department under this subsection shall be available within the time specified by 11 the commission.

12(d) Any report prepared by the department for the commission under sub. (2m), 13and any materials or documents prepared by the department for use at a public 14 hearing under sub. (2m), shall be available on the 15th day after the date on which 15the report under sub. (2m) is submitted to the commission if no member of the 16 commission notifies the department within 14 days of the report's submission that 17the commission will schedule a public hearing on the proposed project design 18 changes, or, if any member of the commission notifies the department under sub. 19 (2m) that the commission will schedule a public hearing under sub. (2m), on the day 20of the public hearing at a time following the public hearing.".

4. Page 5, line 12: after "13.489" insert "(2m) and".

22 **5.** Page 5, line 15: after that line insert:

"(3m) The treatment of section 13.489 (6) of the statutes first applies to reports,
materials, and documents prepared by the department on the effective date of this
subsection.".
