SENATE AMENDMENT 52, TO SENATE SUBSTITUTE AMENDMENT 2, TO 2003 SENATE BILL 214

October 23, 2003 - Offered by Senator CHVALA.

- At the locations indicated, amend the substitute amendment as follows:

 1. Page 22, line 21: after "FORMS." insert "(a)".
- 3 **2.** Page 23, line 6: substitute "paragraph" for "subsection".
- **3.** Page 23, line 9: delete "(e)" and substitute "1.".
- **4.** Page 23, line 11: delete "(f)" and substitute "2.".
- **5.** Page 23, line 14: delete "(g)" and substitute "3.".
- 7 **6.** Page 23, line 17: delete "(h)" and substitute "4.".
- 8 **7.** Page 23, line 20: delete "(i)" and substitute "5.".
- 9 **8.** Page 23, line 21: after that line insert:
- 10 "(bm) The department shall design a prescription drug-information form for 11 individuals who apply for a license under this section to have completed by a

1	physician, as defined in s. 448.01 (5). The department shall complete the design of
2	the form no later than the design of the application form under par. (a). The
3	department shall distribute the forms to any sheriff who issues licenses under sub.
4	(2) (a) or (c) for distribution to applicants. The form shall request all of the following:
5	1. The name and signature of the physician.
6	2. A list of any prescription drugs that the applicant takes on a regular basis.
7	3. A physician statement outlining interactions that the prescription drugs on
8	the list in subd. 2. could have when taken with any other prescription drug on the
9	list in subd. 2. or with any common nonprescription drug product, as defined in s.
10	450.01 (13m).
11	4. A physician statement as to whether the list in subd. 2. contains any
12	prescription drug that could prevent him or her from safely handling a handgun or
13	that is prescribed for any mental illness or for a physical illness that could prevent
14	him or her from safely handling a handgun.".
15	9. Page 24, line 15: after that line insert:
16	"(fm) The completed form described in sub. (5) (bm).".
17	10. Page 30, line 7: after "(a)" insert "or (cm)".
18	11. Page 32, line 11: after that line insert:
19	"(cm) If a licensee is prescribed a prescription drug that is not on his or her list
20	under sub. (5) (bm) 2., the licensee shall have a physician update the form under sub.
21	(7) (fm).".
22	12. Page 39, line 11: after that line insert:

"(dm) 1. A licensee to whom sub. (12) (cm) applies may not carry a concealed

weapon until he or she has a physician update the information under sub. (7) (fm).
