	The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

10 SECTION 1. 16.964 (11) of the statutes is created to read:

11 16.964 (11) From the appropriation under s. 20.505 (6) (gj), the office shall
 12 provide grants to nonprofit organizations that provide services to victims of sexual

1	assault. The office shall develop criteria and procedures for use in selecting grantees
2	and administering the grant program. Notwithstanding s. 227.10 (1), the criteria
3	and procedures need not be promulgated as rules under ch. 227.
4	SECTION 2. 20.410 (1) (gj) of the statutes is created to read:
5	20.410 (1) (gj) General operations; child pornography surcharge. All moneys
6	received as part A of any child pornography surcharge imposed under s. 973.042 to
7	operate institutions and to provide field and administrative services.
8	SECTION 3. 20.455 (2) (gj) of the statutes is created to read:
9	20.455 (2) (gj) General operations; child pornography surcharge. All moneys
10	received as part B of any child pornography surcharge imposed under s. 973.042 for
11	investigating offenses under s. 948.05 or 948.12.
12	SECTION 4. 20.505 (6) (gj) of the statutes is created to read:
13	20.505 (6) (gj) Grants for victims of sexual assault; child pornography
14	surcharge. All moneys received as part C of any child pornography surcharge
15	imposed under s. 973.042 for the grant program under s. 16.964 (11).
16	SECTION 5. 46.07 of the statutes, as affected by 2005 Wisconsin Act 25, is
17	amended to read:
18	46.07 Property of patients or residents. All money including wages and

other property delivered to an officer or employee of any institution for the benefit of a patient or resident shall <u>immediately</u> be delivered to the steward, who shall enter the money upon the steward's books to the credit of the patient or resident. The property shall be used only under the direction and with the approval of the superintendent and for the crime victim and witness assistance surcharge under s. 973.045 (4), the delinquency victim and witness assistance surcharge under s. 938.34 (8d) (c), the deoxyribonucleic acid analysis surcharge under s. 973.046, <u>the child</u>

pornography surcharge under s. 973.042, the drug offender diversion surcharge 1 2 under s. 973.043, or the benefit of the patient or resident. If the money remains 3 uncalled for for one year after the patient's or resident's death or departure from the 4 institution, the superintendent shall deposit the money in the general fund. If any 5 patient or resident leaves property, other than money, uncalled for at an institution 6 for one year, the superintendent shall sell the property, and the proceeds shall be 7 deposited in the general fund. If any person satisfies the department, within 5 years 8 after the deposit, of his or her right to the deposit, the department shall direct the 9 department of administration to draw its warrant in favor of the claimant and it shall 10 charge the same to the appropriation made by s. 20.913 (3) (c).

SECTION 6. 301.32 (1) of the statutes, as affected by 2005 Wisconsin Act 25, is
amended to read:

13 301.32(1) PROPERTY DELIVERED TO WARDEN OR SUPERINTENDENT; CREDIT AND DEBIT. 14 All money and other property delivered to an employee of any state correctional 15institution for the benefit of a prisoner or resident shall be delivered to the warden 16 or superintendent, who shall enter the property upon his or her accounts to the credit 17of the prisoner or resident. The property may be used only under the direction and with the approval of the superintendent or warden and for the crime victim and 18 19 witness assistance surcharge under s. 973.045 (4), the delinquency victim and 20 witness assistance surcharge under s. 938.34 (8d) (c), the deoxyribonucleic acid 21analysis surcharge under s. 973.046, the child pornography surcharge under s. 22 973.042, the drug offender diversion surcharge under s. 973.043, or the benefit of the 23prisoner or resident. If the money remains uncalled for for one year after the 24prisoner's or resident's death or departure from the state correctional institution, the superintendent shall deposit it in the general fund. If any prisoner or resident leaves 25

property, other than money, uncalled for at a state correctional institution for one year, the superintendent shall sell the property and deposit the proceeds in the general fund, donate the property to a public agency or private, nonprofit organization or destroy the property. If any person satisfies the department, within 5 years after the deposit, of his or her right to the deposit, the department shall direct the department of administration to draw its warrant in favor of the claimant and it shall charge the same to the appropriation made by s. 20.913 (3) (bm).

8 SECTION 7. 302.13 of the statutes, as affected by 2005 Wisconsin Act 25, is 9 amended to read:

10 **302.13** Preservation of property an inmate brings to prison. The 11 department shall preserve money and effects, except clothes, in the possession of an 12 inmate when admitted to the prison and, subject to the crime victim and witness 13 assistance surcharge under s. 973.045 (4), the deoxyribonucleic acid analysis 14 surcharge under s. 973.046, the child pornography surcharge under s. 973.042, and 15 the drug offender diversion surcharge under s. 973.043, shall restore the money and 16 effects to the inmate when discharged.

SECTION 8. 303.01 (8) (b) of the statutes, as affected by 2005 Wisconsin Act 25,
is amended to read:

19 303.01 (8) (b) The department shall distribute earnings of an inmate or 20 resident, other than an inmate or resident employed under sub. (2) (em), for the crime 21 victim and witness assistance surcharge under s. 973.045 (4), for the delinquency 22 victim and witness assistance surcharge under s. 938.34 (8d) (c), for the 23 deoxyribonucleic acid analysis surcharge under s. 973.046 (4) and for compliance 24 with s. 303.06 (2) and may distribute earnings for the support of the inmate's or 25 resident's dependents and for other obligations either acknowledged by the inmate

9	SECTION 26. 973.042 of the statutes is created to read:

12	exposed film, and data representing a visual image.
13	(2) If a court imposes a sentence or places a person on probation for a crime
14	under s. 948.05 or 948.12 and the person was at least 18 years of age when the crime
15	was committed, the court shall impose a child pornography surcharge of \$500 for
16	each image or each copy of an image associated with the crime. The court shall
17	determine the number of images or copies of images associated with the crime by a
18	preponderance of the evidence and without a jury.
19	(3) The clerk shall record any surcharge imposed under this section in 3 parts
20	as follows:
21	(a) Part A is 50 percent of any amount collected.
22	(b) Part B is 30 percent of any amount collected.
23	(c) Part C is 20 percent of any amount collected.
24	(4) After determining the amount due, the clerk of court shall collect and
25	transmit the amount to the county treasurer under s. 59.40 $\left(2\right)$ (m). The county

treasurer shall then make payment to the secretary of administration under s. 59.25

(5) The secretary of administration shall credit part A of the surcharge to the
appropriation account under s. 20.410 (1) (gj). The secretary of administration shall
credit part B of the surcharge to the appropriation account under s. 20.455 (2) (gj).
The secretary of administration shall credit part C of the surcharge to the
appropriation account under s. 20.505 (6) (gj).

8 (6) If an inmate in a state prison or a person sentenced to a state prison has 9 not paid the child pornography surcharge under this section, the department shall 10 assess and collect the amount owed from the inmate's wages or other moneys. Any 11 amount collected under this subsection shall be transmitted to the secretary of 12 administration.

SECTION 28. Initial applicability.

16 (1) The treatment of section 973.042 of the statutes first applies to violations
17 of section 948.05 or 948.12 of the statutes that are committed on the effective date
18 of this subsection.
