



**ASSEMBLY AMENDMENT 19,
TO 2005 ASSEMBLY RESOLUTION 6**

June 16, 2005 – Offered by Representative SCHNEIDER.

1 At the locations indicated, amend the resolution as follows:

2 **1.** Page 3, line 11: after that line insert:

3 “**SECTION 5m.** Assembly rule 32 (1) (a) is amended to read:

4 ASSEMBLY RULE 32 (1) (a) ~~Except as otherwise provided in this paragraph,~~
5 ~~messages~~ Messages from the senate or from the governor may be received and read,
6 and any proposal referenced in the messages that is a senate proposal initially
7 received for consideration of the assembly shall be referred and any other proposals
8 referenced in the messages shall be taken up immediately unless referred by the
9 presiding officer to a standing committee or to the calendar. ~~Any messages from the~~
10 ~~senate referring to a senate joint resolution memorializing Congress or any branch~~
11 ~~or officer of the federal government that is received for consideration of the assembly~~
12 ~~may be read but the senate joint resolution may not be received for consideration.~~

1 ~~The senate joint resolution shall be transmitted to the senate immediately after the~~
2 ~~message is read;~~”.

3 **2.** Page 3, line 19: after that line insert:

4 “**SECTION 7e.** Assembly rule 39 (1) is amended to read:

5 ASSEMBLY RULE 39 (1) ~~Except as otherwise provided in joint rule 83 (2) and this~~
6 ~~subsection, any member or standing committee may introduce or offer proposals in~~
7 ~~the assembly on any day of the biennial legislative session. No member or standing~~
8 ~~committee may offer any assembly joint resolution or resolution memorializing~~
9 ~~Congress or any branch or officer of the federal government.~~

10 **SECTION 7r.** Assembly rule 41 (1) is amended to read:

11 ASSEMBLY RULE 41 (1) ~~Except as further provided in subs. (2) and (3) and except~~
12 ~~as otherwise provided in this subsection, any assembly joint resolution or resolution,~~
13 ~~and any senate joint resolution received by the assembly for consideration, shall~~
14 ~~receive a reading on each of 2 separate and nonconsecutive legislative days under the~~
15 ~~appropriate order of business designated in rule 31. Unless otherwise ordered, each~~
16 ~~reading shall consist of reading the relating clause in the resolution’s title or on first~~
17 ~~reading be as provided in rule 42 (2) or (3). This subsection does not apply to any~~
18 ~~senate joint resolution that the assembly is prohibited from considering under rule~~
19 ~~32(1)(a).”.~~
