**ASSEMBLY AMENDMENT 1,
TO 2009 ASSEMBLY BILL 725**

April 1, 2010 – Offered by Representative ZIGMUNT.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 1, line 2: delete that line and substitute “cardiopulmonary
resuscitation and cardiocerebral resuscitation and about”.
- 3 **2.** Page 1, line 3: delete “defibrillator” and substitute “defibrillators”.
- 4 **3.** Page 2, line 1: delete “2010-11” and substitute “2011-12”.
- 5 **4.** Page 2, line 4: delete “offer instruction in cardiopulmonary resuscitation,”
and substitute “do all of the following:”.
- 6 **5.** Page 2, line 4: after that line insert:
- 7 “(a) Offer instruction in cardiopulmonary resuscitation and”.
- 8 **6.** Page 2, line 5: delete “, and the use of an automated external defibrillator”.
- 9 **7.** Page 2, line 10: delete the material beginning with “and to use” and ending
with “defibrillator” on line 11.

1 **8.** Page 2, line 12: delete “(a)” and substitute “1.”

2 **9.** Page 2, line 14: delete “(b)” and substitute “2.”

3 **10.** Page 2, line 15: delete “and the use of an automated external”.

4 **11.** Page 2, line 16: delete “defibrillator”.

5 **12.** Page 2, line 16: after that line insert:

6 “(b) Provide instruction about automated external defibrillators to pupils
7 enrolled in the high school grades in the school district, charter school, or private
8 school.

9 **SECTION 1m.** 119.04 (1) of the statutes, as affected by 2009 Wisconsin Acts 60

17 118.52, 118.55, 120.12 (5) and (15) to (25), 120.125, 120.13 (1), (2) (b) to (g), (3), (14),
18 (17) to (19), (26), (34), (35), (37), (37m), and (38), 120.14, 120.21 (3), and 120.25 are
19 applicable to a 1st class city school district and board.”.
