**ASSEMBLY AMENDMENT 1,
TO 2009 ASSEMBLY BILL 76**

April 1, 2009 – Offered by COMMITTEE ON HEALTH AND HEALTHCARE REFORM.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 1, line 4: after “licenses” insert “and identification cards”.
- 3 **2.** Page 2, line 13: after “(a),” insert “or identification card”.
- 4 **3.** Page 2, line 15: after “document” insert “or identification card”.
- 5 **4.** Page 2, line 18: on lines 18 and 19, after “licensee” insert “or card holder”.
- 6 **5.** Page 3, line 2: on lines 2 and 5, after “document” insert “or identification
card”.
- 7 **6.** Page 3, line 3: after “licensee’s” insert “or card holder’s”.
- 8 **7.** Page 3, line 4: after “licensee” insert “or card holder”.
- 9 **8.** Page 3, line 6: delete “a portion” and substitute “portions”.
- 10 **9.** Page 3, line 7: after “licensing” insert “and identification cards”.
- 11 **10.** Page 3, line 12: after that line insert:

1 **“SECTION 2g.** 343.50 (3) of the statutes is amended to read:

2 **343.50 (3) DESIGN AND CONTENTS OF CARD.** The card shall be the same size as
3 an operator’s license but shall be of a design which is readily distinguishable from
4 the design of an operator’s license and bear upon it the words “IDENTIFICATION
5 CARD ONLY”. The information on the card shall be the same as specified under s.
6 343.17 (3). The card may serve as a record of gift under s. 157.06 (2) (t) and the holder
7 may affix a sticker thereto as provided in s. 343.175 (3). The card may also serve as
8 a record of refusal under s. 157.06 (2) (u). The card shall contain the holder’s
9 photograph and, if applicable, shall be of the design specified under s. 343.17 (3) (a)
10 12. A part of the reverse side of the card shall be printed to allow the card holder to
11 write on the card information authorized by rule under s. 343.177 (1).

12 **SECTION 2r.** 343.50 (3) of the statutes, as affected by 2007 Wisconsin Act 20 and
13 2009 Wisconsin Act (this act), is repealed and recreated to read:

14 **343.50 (3) DESIGN AND CONTENTS OF CARD.** The card shall be the same size as
15 an operator’s license but shall be of a design which is readily distinguishable from
16 the design of an operator’s license and bear upon it the words “IDENTIFICATION
17 CARD ONLY.” The information on the card shall be the same as specified under s.
18 343.17 (3). If the issuance of the card requires the applicant to present any
19 documentary proof specified in s. 343.14 (2) (es) 4. to 7., the card shall display, on the
20 front side of the card, a legend identifying the card as temporary. The card shall
21 contain physical security features consistent with any requirement under federal
22 law. The card may serve as a record of gift under s. 157.06 (2) (t) and the holder may
23 affix a sticker thereto as provided in s. 343.175 (3). The card may also serve as a
24 record of refusal under s. 157.06 (2) (u). The card shall contain the holder’s
25 photograph and, if applicable, shall be of the design specified under s. 343.17 (3) (a)

1 12. A part of the reverse side of the card shall be printed to allow the card holder to
2 write on the card information authorized by rule under s. 343.177 (1).”.

3 **11.** Page 4, line 7: after “licenses” insert “and identification cards”.

4 **12.** Page 4, line 11: after that line insert:

5 “(2) The repeal and recreation of section 343.50 (3) of the statutes takes effect
6 on the first day of the 6th month beginning after publication, or on the date on which
7 the creation of section 343.165 of the statutes by 2007 Wisconsin Act 20 takes effect,
8 whichever is later.”.
