**SENATE AMENDMENT 6,
TO 2011 ASSEMBLY BILL 40**

June 16, 2011 – Offered by Senators HOLPERIN, S. COGGS, T. CULLEN, TAYLOR, MILLER, WIRCH, VINEHOUT, C. LARSON, CARPENTER, HANSEN, JAUCH, LASSA, RISSER and ERPENBACH.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 175, line 11: increase the dollar amount for fiscal year 2011–12 by
3 \$2,039,300 and increase the dollar amount for fiscal year 2012–13 by \$1,892,300 to
4 increase funding for the purposes for which the appropriation is made.

5 **2.** Page 175, line 13: increase the dollar amount for fiscal year 2011–12 by
6 \$6,374,100 and increase the dollar amount for fiscal year 2012–13 by \$6,178,100 to
7 increase funding for the purposes for which the appropriation is made.

8 **3.** Page 175, line 15: increase the dollar amount for fiscal year 2011–12 by
9 \$1,228,600 and increase the dollar amount for fiscal year 2012–13 by \$1,228,600 to
10 increase funding for the purposes for which the appropriation is made.

11 **4.** Page 177, line 10: increase the dollar amount for fiscal year 2011–12 by
12 \$646,300 and increase the dollar amount for fiscal year 2012–13 by \$2,585,300 to
13 increase funding for the purposes for which the appropriation is made.

1 **5.** Page 177, line 12: increase the dollar amount for fiscal year 2011-12 by
2 \$146,300 and increase the dollar amount for fiscal year 2012-13 by \$585,200 to
3 increase funding for the purposes for which the appropriation is made.

4 **6.** Page 177, line 14: increase the dollar amount for fiscal year 2011-12 by
5 \$1,714,600 and increase the dollar amount for fiscal year 2012-13 by \$6,858,300 to
6 increase funding for the purposes for which the appropriation is made.

7 **7.** Page 177, line 16: increase the dollar amount for fiscal year 2011-12 by
8 \$450,500 and increase the dollar amount for fiscal year 2012-13 by \$1,802,100 to
9 increase funding for the purposes for which the appropriation is made.

10 **8.** Page 182, line 10: increase the dollar amount for fiscal year 2011-12 by
11 \$1,352,800 and increase the dollar amount for fiscal year 2012-13 by \$1,352,800 to
12 increase funding for the bicycle and pedestrian facilities program.

13 **9.** Page 638, line 4: after that line, delete the material inserted by assembly
14 amendment 1 to assembly amendment 1.

15 **10.** Page 644, line 6: after that line, delete the material inserted by assembly
16 amendment 1 to assembly amendment 1.

17 **11.** Page 651, line 14: after that line, delete the material inserted by assembly
18 amendment 1 to assembly amendment 1.

19 **12.** Page 662, line 6: delete lines 6 to 17.

20 **13.** Page 664, line 18: delete lines 18 to 25.

21 **14.** Page 898, line 17: after that line insert:

22 “**SECTION 2214m.** 84.013 (3m) (g) of the statutes is created to read:

1 84.013 **(3m)** (g) The department shall construct an interchange at USH 51 and
2 CTH “C” in Lincoln County when the department constructs an overpass at this
3 intersection.”.

4 **15.** Page 922, line 15: delete lines 15 and 16 and substitute “calendar year
5 2010, and \$68,583,200 for aid payable for calendar year 2011 and thereafter, to the
6 eligible”.

7 **16.** Page 923, line 2: delete lines 2 and 3 and substitute “calendar year 2010,
8 and \$18,021,300 for aid payable for calendar year 2011 and thereafter, to the
9 eligible”.

10 **17.** Page 923, line 13: delete “, and” and substitute “; and”.

11 **18.** Page 923, line 14: delete “, and \$23,267,200 in calendar year 2012”.

12 **19.** Page 923, line 20: delete “, and” and substitute “; and”.

13 **20.** Page 923, line 20: delete the material beginning with “, and” and ending
14 with “2012” on line 21.

15 **21.** Page 924, line 21: delete lines 21 to 23.

16 **22.** Page 926, line 5: delete “\$94,615,600”, as affected by assembly
17 amendment 1 to assembly amendment 1, and substitute “\$96,507,900”.

18 **23.** Page 926, line 12: delete “\$308,904,300” and substitute “\$315,082,400”.

19 **24.** Page 926, line 25: delete the material inserted by assembly amendment
20 1 to assembly amendment 1.

21 **25.** Page 929, line 3: delete the material inserted by assembly amendment 1
22 to assembly amendment 1.

23 **26.** Page 1482, line 18: after that line insert:

1 “(11q) GRANT TO THE TOWN OF POUND. Notwithstanding the requirement in 2007
2 Wisconsin Act 20, section 9148 (11x), that the grant be for the extension of N. 19th
3 Road to W. 16th Road, the town of Pound in Marinette County may use the grant
4 awarded by the department of transportation under 2007 Wisconsin Act 20, section
5 9148 (11x), for any suitable local highway project.”.

6 **27.** Page 1514, line 10: delete lines 10 to 13, as affected by assembly
7 amendment 1 to assembly amendment 1.

8 **28.** Page 1526, line 21: delete lines 21 to 24, as affected by assembly
9 amendment 1 to assembly amendment 1.
