ASSEMBLY AMENDMENT 5, TO 2011 ASSEMBLY BILL 92

May 10, 2011 – Offered by Representatives Kessler, Richards, Sinicki, Zamarripa, Pasch, Turner, Danou, Mason, D. Cullen, Grigsby, Zepnick, Toles and Krusick.

1	At the locations indicated, amend the bill as follows:
2	1. Page 1, line 4: after "Program" insert ", changing funding of the program,".
3	2. Page 2, line 1: before that line insert:
4	"SECTION 1d. 20.255 (2) (ac) of the statutes is amended to read:
5	20.255 (2) (ac) General equalization aids. The amounts in the schedule for the
6	payment of educational aids under ss. 121.08, 121.09, 121.095, <u>and</u> 121.105 , 121.137
7	and subch. VI of ch. 121.
8	SECTION 1h. 74.09 (3) (dd) of the statutes is created to read:
9	74.09 (3) (dd) For Milwaukee, indicate the amount of any taxes levied to make
10	up for a reduction in general school aids as a result of the program under s. 119.23.
11	SECTION 1p. 74.09 (3) (gd) of the statutes is created to read:
12	74.09 (3) (gd) For Milwaukee, include a notice that provides information on the
13	financing of the program under s. 119.23.".

- 3 "SECTION 7b. 119.46 (1) of the statutes is amended to read:

119.46 (1) As part of the budget transmitted annually to the common council 4 5 under s. 119.16 (8) (b), the board shall report the amount of money required for the 6 ensuing school year to operate all public schools in the city under this chapter, to repair and keep in order school buildings and equipment, to make material 7 8 improvements to school property and to purchase necessary additions to school sites. 9 The amount included in the report for the purpose of supporting the Milwaukee 10 Parental Choice Program under s. 119.23 shall be reduced by the amount of aid 11 received by the board under s. 121.136 and by the amount specified in the notice 12received by the board under s. 121.137 (2). The common council shall levy and collect 13 a tax upon all the property subject to taxation in the city, which shall be equal to the 14 amount of money required by the board for the purposes set forth in this subsection. 15at the same time and in the same manner as other taxes are levied and collected. 16 Such taxes shall be in addition to all other taxes which the city is authorized to levy. 17The taxes so levied and collected, any other funds provided by law and placed at the 18 disposal of the city for the same purposes, and the moneys deposited in the school 19 operations fund under s. 119.60 (1), shall constitute the school operations fund.

14	SECTION 7r. 121.137 of the statutes is repealed.
15	SECTION 7u. 121.90 (2) (am) 4. of the statutes is repealed.".
16	5. Page 3, line 18: after that line insert:
17	"(1g) The creation of section 74.09 (3) (dd) and (gd) of the statutes first applies
18	to the property tax assessments as of January 1, 2012.".
19	6. Page 3, line 19: delete "(1)" and substitute "(1r)".
20	7. Page 4, line 4: after that line insert:
21	" $(3m)$ The treatment of section 121.08 (4) (b) (intro.), 1., 2., and 3. of the statutes
22	first applies to state aid paid in the 2011–12 school year.".
