## SENATE AMENDMENT 8, TO SENATE SUBSTITUTE AMENDMENT 1, TO 2011 SENATE BILL 461

March 6, 2012 – Offered by Senators Lassa, Wirch, S. Coggs, T. Cullen, C. Larson, Shilling, Miller, Hansen, Risser, Erpenbach and Carpenter.

1	At the locations indicated, amend the substitute amendment as follows:
2	<b>1.</b> Page 1, line 11: after "effectiveness," insert "the hours that a minor may
3	work,".
4	<b>2.</b> Page 5, line 13: after that line insert:
5	"SECTION 14g. 103.24 of the statutes, as affected by 2011 Wisconsin Act 32, is
6	amended to read:
7	<b>103.24 Hours of work.</b> The department shall determine and fix reasonable
8	hours of employment for minors <del>under 16 years of age</del> in street trades. Except as
9	provided in this section, the department may not fix hours of employment for minors
10	under 16 years of age in street trades that exceed the maximum hours per day and
11	per week specified in s. 103.68 (2) (a) and (b), that exceed the maximum days per
12	week specified in s. 103.68 (2) (c), or that begin earlier or end later than the hours

1	specified in s. 103.68 (2) (d) and (e). The department may not limit the hours of
2	employment for minors 16 years of age or over in street trades or the hours of
3	employment for minors of any age who are engaged in the delivery of newspapers to
4	the consumer.
5	<b>SECTION 14m.</b> 103.65 (2) of the statutes, as affected by 2011 Wisconsin Act 32,
6	is amended to read:
7	103.65 (2) No minor <del>under 16 years of age</del> may be employed or permitted to
8	work at any employment for such hours of the day or week, for such days of the week,
9	or at such periods of the day as may be dangerous or prejudicial to the life, health,
10	safety, or welfare of the minor.
11	<b>SECTION 14p.</b> 103.66 (2) of the statutes, as affected by 2011 Wisconsin Act 32,
12	is amended to read:
13	103.66 (2) The department may investigate and fix reasonable classifications
14	of employments and hours of employment for minors <del>under 16 years of age</del> and may
15	issue general or special orders fixing for those minors maximum hours of
16	employment per day and per week, maximum days of employment per week, hours
17	at which employment may begin and end, and the duration of lunch and other rest
18	periods as are necessary to protect the life, health, safety, and welfare of those
19	minors. For minors under 16 years of age, the department may not fix hours of
20	employment that exceed the maximum hours per day and per week specified in s.
21	103.68 (2) (a) and (b), that exceed the maximum days per week specified in s. 103.68
22	(2) (c), or that begin earlier or end later than the hours specified in s. 103.68 (2) (d)
23	and (e). For minors 16 years of age or over, the department may fix the duration of
24	lunch and other rest periods, but may not limit hours of employment or issue general
25	or special orders fixing maximum hours of employment per day or per week,

1 maximum days of employment per week, or hours at which employment may begin 2 and end. 3 SECTION 14r. 103.68 (1) of the statutes, as affected by 2011 Wisconsin Act 32, 4 is amended to read: 103.68 (1) No Except as provided in sub. (2), no minor may be employed or 5 6 permitted to work at in any gainful occupation, other than in domestic service, farm 7 labor, or service as an election inspector under s. 7.30 (2) (am), for more than 8 hours 8 in any one day, for more than 40 hours in any one week, or for more than 6 days in 9 any one week, or during such hours as the minor is required under s. 118.15 to attend 10 school. 11 **SECTION 14t.** 103.68 (2) (intro.) of the statutes, as affected by 2011 Wisconsin 12Act 32, is renumbered 103.68 (2) and amended to read: 13103.68 (2) No minor under 16 years of age may be employed or permitted to 14 work in any gainful occupation, other than in domestic service, or farm labor, for more than 24 hours in any one week or before 7 a.m. or after 6 p.m., except in domestic 1516 service, farm labor, street trades, as defined in s. 103.21 (6), or public exhibitions, as 17provided in s. 103.78, as follows: 18 **SECTION 14v.** 103.68 (2) (a) to (e) of the statutes, as created by 2011 Wisconsin 19 Act 32, are repealed.". 20(END)
