1	At the locations indicated, amend the bill as follows:
2	1. Page 7, line 22: after that line insert:
3	"SECTION 6g. 35.93 (2) (b) 4. of the statutes, as affected by 2013 Wisconsin Act
4	20, is amended to read:
5	35.93 (2) (b) 4. Copies of all rules filed with the legislative reference bureau
6	under s. 227.20 (1) or modified under s. 227.265 since the compilation of the
7	preceding register, including emergency rules filed under s. 227.24 (3).
8	SECTION 6r. 35.93 (2) (c) 1. of the statutes, as affected by 2013 Wisconsin Act
9	20, is amended to read:
10	35.93 (2) (c) 1. Each chapter of the Wisconsin administrative code that has been
11	affected by rules filed with legislative reference bureau under s. 227.20 (1) $\underline{\text{or}}$
12	modified under s. 227.265, in accordance with sub. (3) (e) 1.".
13	2. Page 8, line 12: after that line insert:

1	"SECTION 7g. 35.93 (3) (e) (intro.) of the statutes, as affected by 2013 Wisconsin
2	Act 20, is amended to read:
3	35.93 (3) (e) (intro.) The legislative reference bureau shall incorporate into the
4	appropriate chapters of the Wisconsin administrative code each permanent rule filed
5	with the legislative reference bureau under s. 227.20 (1) <u>or modified under s. 227.265</u>
6	and, for each chapter of the administrative code affected by a rule, do all of the
7	following:
8	SECTION 7r. 35.93 (3) (e) 1. of the statutes, as affected by 2013 Wisconsin Act
9	20, is amended to read:
10	35.93 (3) (e) 1. Publish the chapter in the appropriate end-of-month register
11	in accordance with the filing deadline for publication established in the rules
12	procedures manual published under s. 227.15 (7) or, in an end-of-month register
13	agreed to by the submitting agency and the legislative reference bureau <u>, or, in the</u>
14	case of a rule modified under s. 227.265, in the end–of–month register for the month
15	in which the bill modifying the rule is enacted.".
16	3. Page 12, line 24: after " <u>authorization</u> " insert " <u>and vehicle operation has not</u>
17	<u>commenced</u> ".
18	4. Page 18, line 14: delete lines 14 to 18.
19	5. Page 21, line 15: delete lines 15 to 18 and substitute:
20	"SECTION 72m. Effective dates. This act takes effect on the day after
21	publication, except as follows:
22	(1) The treatment of section 35.93 (2) (b) 4. and (c) 1. and (3) (e) (intro.) and 1.
23	of the statutes takes effect on January 1, 2015.".
