



**SENATE AMENDMENT 18,
TO SENATE SUBSTITUTE AMENDMENT 2,
TO SENATE BILL 1**

February 27, 2013 – Offered by Senator TAYLOR.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 3, line 4: after that line insert:

3 “**SECTION 3d.** 20.445 (1) (gm) of the statutes is created to read:

4 20.445 (1) (gm) *Mining industry jobs training grants.* A sum sufficient for
5 mining skills training grants under s. 106.05 and for mining equipment
6 manufacturing training grants under s. 106.35.”

7 **2.** Page 7, line 18: delete the material beginning with that line and ending with
8 page 8, line 2, and substitute:

9 “**SECTION 32d.** 70.395 (1e) of the statutes is amended to read:

10 70.395 (1e) DISTRIBUTION. Fifteen days after the collection of the tax under ss.
11 70.38 to 70.39, the department of administration, upon certification of the
12 department of revenue, shall transfer the amount collected in respect to mines not

1 in operation on November 28, 1981, to the investment and local impact fund, except
2 that the department of administration shall transfer 60 percent of the amount
3 collected from each person extracting ferrous metallic minerals in this state to the
4 investment and local impact fund and 40 percent of the amount collected from any
5 such person to the general fund.”.

6 **3.** Page 12, line 22: after that line insert:

7 “**SECTION 43d.** 106.05 of the statutes is created to read:

8 **106.05 Mining skills training grants.** From the appropriation account
9 under s. 20.445 (1) (gm), the department, in consultation with the Wisconsin
10 Economic Development Corporation, shall award a grant annually of not more than
11 \$500,000 to Cooperative Educational Service Agency Number 12 or to an
12 organization operating a skills improvement apprenticeship program that is
13 authorized to administer the operating engineers certification program and to
14 provide training in the operation of heavy equipment, for the purposes of
15 establishing, funding, and facilitating cross-training partnership programs
16 between that agency and that organization.

17 **SECTION 43e.** 106.35 of the statutes is created to read:

18 **106.35 Mining equipment manufacturing training grants.** From the
19 appropriation account under s. 20.445 (1) (gm), the department, in consultation with
20 the Wisconsin Economic Development Corporation, shall award a grant annually of
21 not more than \$500,000 to Cooperative Educational Service Agency Number 1 or to
22 an organization operating an economic and workforce development center in the
23 southeastern area of this state to establish, fund, and facilitate cross-training
24 partnership programs between that service agency and that organization for the

1 purpose of establishing classroom curriculum and hands-on job training programs
2 that provide individuals with the opportunity to receive instruction relating to the
3 performance of manufacturing jobs in facilities in that area that are involved in
4 producing equipment and products related to the mining industry.”
