## ASSEMBLY AMENDMENT 1, TO ASSEMBLY BILL 251

January 14, 2016 - Offered by Representative NEYLON.

At the locations indicated, amend the bill as follows:

1. Page 7, line 7: delete "(ks)" and substitute "(kt)".
2. Page 7, line 8: delete "(ks)" and substitute "(kt)".
3. Page 7, line 10: after that line insert:
"SECTION 4m. 20.765 (1) (kt) of the statutes is created to read:
20.765 (1) (kt) Independent economic analyses for administrative rules. All moneys received under s. 227.137 (4m) (b) 3. a. to reimburse persons for conducting independent economic impact analyses under ss. 227.137 (4m) (b) 3. and 227.19 (5) (b) $3 . "$.
4. Page 12, line 21: delete "(intro.), (a) and (b)" and substitute "(intro.) and (a)".
5. Page 13, line 16: after that line insert:
"SECTION 19g. 227.137 (3) (b) of the statutes is renumbered 227.137 (3) (b) (intro.) and amended to read:".
6. Page 13, line 17: delete "(b)" and substitute " 227.137 (3) (b) (intro.)".
7. Page 13, line 20: delete "rule," and substitute "rule-,".
8. Page 13 , line 21 : delete lines 21 to 25 and substitute "specifically including all of the following:".
9. Page 14, line 1: before that line insert:
"SECTION 19r. 227.137 (3) (b) 1. and 2. of the statutes are created to read:
227.137 (3) (b) 1. An estimate of the total implementation and compliance costs that are reasonably expected to be incurred by or passed along to businesses, local governmental units, and individuals as a result of the proposed rule, expressed as a single dollar figure. With respect to an independent economic impact analysis prepared under s. 227.137 , the person preparing the analysis shall provide a detailed explanation of any variance from the agency's estimate under this subdivision.
10. A determination, for purposes of the requirement under s. 227.139, as to whether $\$ 10$ million or more in implementation and compliance costs are reasonably expected to be incurred by or passed along to businesses, local governmental units, and individuals over any 2-year period as a result of the proposed rule.".
11. Page 16, line 7: delete "(ks)" and substitute "(kt)".
12. Page 16, line 9: delete "(ks)" and substitute "(kt)".
13. Page 16, line 13: delete "The committee shall" and substitute "Costs of completing the independent economic impact analysis shall be paid as follows:".
14. Page 16 , line 14 : delete lines 14 and 15 and substitute:
"a. If the estimate in the independent economic impact analysis of total implementation and compliance costs under s. 227.137 (3) (b) 1. varies from the agency's estimate by 15 percent or more or varies from the agency's determination that there will be no implementation or compliance costs, the committee shall assess the agency that is proposing the proposed rule for those costs. The committee shall credit all moneys received under this subd. 3. a. to the appropriation account under s. 20.765 (1) (kt) and shall reimburse the person from the appropriation account under s. 20.765 (1) (kt).
b. If the estimate in the independent economic impact analysis of total implementation and compliance costs under s. 227.137 (3) (b) 1. does not vary from the agency's estimate by 15 percent or more or is in accord with the agency's determination that there will be no implementation and compliance costs, the committee shall reimburse the person in equal parts from the appropriation accounts under s. 20.765 (1) (a) and (b).".
15. Page 29, line 1: delete the material beginning with "The committee shall" and ending with "(b)." on line 3 and substitute "Costs of completing the independent economic impact analysis shall be paid as provided in s. 227.137 (4m) (b) 2. a. and b.".
16. Page 34, line 21: delete "(intro.), (a), and (b)" and substitute "(intro.) and (a)".
17. Page 35 , line 2: after " 16.28 (1)," insert " 227.137 (3) (b)".
18. Page 35 , line 4: after "(b) to (e)," insert " 227.137 (3) (b) 1. and 2.". (END)
