## ASSEMBLY AMENDMENT 3, TO ASSEMBLY BILL 430

November 5, 2015 - Offered by Representative Murtha.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 3, line 4: before "abuse" insert "sexual".
- 3 **2.** Page 3, line 6: delete "ss. 948.01 to 948.11" and substitute "s. 948.02,
- 4 948.025, or 948.05 to 948.11".
- 5 **3.** Page 3, line 11: before "abuse" insert "sexual".
- 4. Page 3, line 13: after "violation." insert "This paragraph does not apply to
  an interview conducted at or on behalf of a child advocacy center.".
- 8 **5.** Page 4, line 1: after "(b)" insert "1.".
- 9 **6.** Page 4, line 1: after "who is" insert "at least 10 years of age and who is".
- 7. Page 4, line 2: before "abuse" insert "sexual".
- 11 **8.** Page 4, line 4: before "abuse" insert "sexual".
- 12 **9.** Page 4, line 4: after that line insert:

- "2. A hospital may make a request under par. (a) for a victim advocate to accompany a minor who has not attained the age of 10 and who is a victim of sexual assault, human trafficking, or child sexual abuse."
- **10.** Page 4, line 5: before "abuse" insert "sexual".
- **11.** Page 4, line 8: after "minor" insert "who is at least 10 years of age".
- **12.** Page 4, line 14: before "abuse" insert "sexual".
- **13.** Page 5, line 21: before "abuse" insert "sexual".
- **14.** Page 5, line 22: after "minor" insert "who is at least 10 years of age".
- **15.** Page 6, line 5: before "abuse" insert "sexual".
- **16.** Page 6, line 12: before "abuse" insert "sexual".
- **17.** Page 6, line 12: delete "<u>ss. 948.01 to</u>" and substitute "<u>s. 948.02, 948.025,</u> 12 or 948.05 to 948.11.".
- **18.** Page 6, line 13: delete that line.
- **19.** Page 7, line 19: delete the material beginning with ", or the report of" and ending with "948.11" on line 20.
- 20. Page 8, line 2: delete "or 948.015 to 948.11" and substitute "948.02, 948.025, or 948.05 to 948.11".
  - **21.** Page 8, line 4: after that line insert:
    - "(am) A parent, guardian, or legal custodian of a minor who is a victim of sexual assault, human trafficking, or child sexual abuse may make a request under par. (a) for a victim advocate to accompany the minor victim of sexual assault, human trafficking, or child sexual abuse.".
      - **22.** Page 8, line 17: after "PROCEEDINGS." insert "(a)".
