SENATE AMENDMENT 33, TO SENATE SUBSTITUTE AMENDMENT 1, TO SENATE BILL 21

July 7, 2015 – Offered by Senators L. Taylor, Miller, C. Larson, Harris Dodd, Risser, Lassa, Hansen, Wirch, Shilling and Vinehout.

At the locations indicated, amend the substitute amendment as follows: 1 2 **1.** Page 199, line 17: increase the dollar amount for fiscal year 2015–16 by 3 \$731,600 and increase the dollar amount for fiscal year 2016-17 by \$731,600 for the 4 purpose of funding the pretrial intoxicated driver intervention grant program. **2.** Page 1157, line 25: delete the material beginning with "\$150,000" and 5 ending with "County," on page 1158, line 2, and substitute "\$150,000 in each fiscal 6 7 year to enter into a contract with an organization that is located in ward 2 in the city 8 of Racine to provide services in Racine County,". **3.** Page 1158, line 9: delete the material beginning with "The" and ending with 9 10 "stats." on line 12 and substitute "The organization that is located in ward 2 in the

city of Racine shall have a recreational facility, shall offer programs to divert youths
