**SENATE AMENDMENT 33,  
TO SENATE SUBSTITUTE AMENDMENT 1,  
TO SENATE BILL 21**

July 7, 2015 - Offered by Senators L. TAYLOR, MILLER, C. LARSON, HARRIS DODD,  
RISSER, LASSA, HANSEN, WIRCH, SHILLING and VINEHOUT.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 199, line 17: increase the dollar amount for fiscal year 2015-16 by  
3 \$731,600 and increase the dollar amount for fiscal year 2016-17 by \$731,600 for the  
4 purpose of funding the pretrial intoxicated driver intervention grant program.

5 **2.** Page 1157, line 25: delete the material beginning with "\$150,000" and  
6 ending with "County," on page 1158, line 2, and substitute "\$150,000 in each fiscal  
7 year to enter into a contract with an organization that is located in ward 2 in the city  
8 of Racine to provide services in Racine County,".

9 **3.** Page 1158, line 9: delete the material beginning with "The" and ending with  
10 "stats." on line 12 and substitute "The organization that is located in ward 2 in the  
11 city of Racine shall have a recreational facility, shall offer programs to divert youths

1 from gang activities, may not be affiliated with any national or state association, and  
2 may not have entered into a contract under s. 301.265 (3), 1995 stats.”.

3 **4.** Page 1295, line 4: delete that line.

4 **5.** Page 1506, line 7: after that line insert:

5 “(1u) TREATMENT AND DIVERSION GRANTS. From the appropriation account under  
6 section 20.455 (2) (em) of the statutes, the department of justice shall award not less  
7 than \$10,000,000 in grants in each fiscal year of the 2015-17 fiscal biennium to  
8 communities with the greatest need for treatment and diversion alternatives.”.

9 **6.** Page 1542, line 16: after that line insert:

10 “(1u) TREATMENT AND DIVERSION GRANTS. In the schedule under section 20.005  
11 (3) of the statutes for the appropriation to the department of justice under section  
12 20.455 (2) (em) of the statutes, as affected by the acts of 2015, the dollar amount is  
13 increased by \$20,000,000 for the first fiscal year of the fiscal biennium in which this  
14 subsection takes effect to provide grants to counties with programs that provide  
15 alternatives to prosecution and incarceration for persons who use alcohol or other  
16 drugs. In the schedule under section 20.005 (3) of the statutes for the appropriation  
17 to the department of justice under section 20.455 (2) (em) of the statutes, as affected  
18 by the acts of 2015, the dollar amount is increased by \$20,000,000 for the 2nd fiscal  
19 year of the fiscal biennium in which this subsection takes effect to provide grants to  
20 counties with programs that provide alternatives to prosecution and incarceration  
21 for persons who use alcohol or other drugs.

22 (1v) BRAY CENTER FUNDING. In the schedule under section 20.005 (3) of the  
23 statutes for the appropriation to the department of justice under section 20.455 (2)  
24 (kj) of the statutes, as affected by the acts of 2015, the dollar amount is increased by

1       \$124,400 for the first fiscal year of the fiscal biennium in which this subsection takes  
2       effect to enter into a contract under s. 165.987 (3) of the statutes with an organization  
3       that is located in ward 2 in the city of Racine to provide services in Racine County.  
4       In the schedule under section 20.005 (3) of the statutes for the appropriation to the  
5       department of justice under section 20.455 (2) (kj) of the statutes, as affected by the  
6       acts of 2015, the dollar amount is increased by \$124,400 for the 2nd fiscal year of the  
7       fiscal biennium in which this subsection takes effect to to enter into a contract under  
8       s. 165.987 (3) of the statutes with an organization that is located in ward 2 in the city  
9       of Racine to provide services in Racine County.”.
