**SENATE SUBSTITUTE AMENDMENT 1,
TO ASSEMBLY BILL 947**

March 26, 2018 - Offered by COMMITTEE ON SENATE ORGANIZATION.

1 **AN ACT to repeal** 6.34 (1) (b) and 6.87 (4) (a) 2.; **to consolidate, renumber and**
2 **amend** 6.34 (1) (intro.) and (a) and 6.87 (4) (a) (intro.) and 1.; **to amend** 5.02
3 (20), 5.05 (13) (c), 5.05 (13) (d) 1., 6.22 (2) (b), 6.22 (2) (e), 6.22 (4) (a), 6.22 (4)
4 (c), 6.24 (2), 6.24 (4) (c), 6.24 (4) (d), 6.24 (4) (e), 6.25 (1) (b), 6.276 (1), 6.865 (1),
5 6.87 (2), 6.87 (3) (d), 6.87 (4) (b) 1., 6.88 (1), 6.97 (1), 7.15 (1) (cm), 7.15 (1) (j),
6 8.50 (2) and 11.0101 (30) (intro.); **to repeal and recreate** 8.50 (4) (d); and **to**
7 **create** 5.02 (12n) of the statutes; **relating to:** absentee ballots cast by overseas
8 and military voters and the timing for holding special elections.

Analysis by the Legislative Reference Bureau

VOTING PROCEDURES FOR MILITARY AND OVERSEAS VOTERS

This substitute amendment modifies current law regarding the voting procedures for military and overseas electors so that the law is in substantial compliance with the federal Uniformed and Overseas Citizens Absentee Voting Act. The substitute amendment also modifies current law so that an individual signing the witness certification for an absentee ballot cast by a military elector or overseas elector need not be a United States citizen.

The substitute amendment allows all overseas electors to receive absentee ballots electronically, regardless of whether such electors are considered permanently or temporarily overseas. Under the substitute amendment, an overseas elector is a U.S. citizen who is residing outside of the United States, who is not disqualified from voting, who has attained or will attain the age of 18 by the date of an election at which the citizen proposes to vote, who was last domiciled in this state or whose parent was last domiciled in this state immediately prior to the parent's departure from the United States, and who is not registered to vote or voting in any other state, territory, or possession.

TIMING FOR HOLDING SPECIAL ELECTIONS

Under this substitute amendment, no special election for the office of state senator or representative to the assembly may be held after the spring election in the year in which a regular election is held to fill that seat. Under current law, any vacancy in the office of state senator or representative to the assembly occurring before the second Tuesday in May in the year in which a regular election is held to fill that seat must be filled as promptly as possible by special election.

The substitute amendment also provides that the date for a special election may not be less than 124 nor more than 154 days from the date of the governor's order calling for the special election and that the primary must be held on the day that is eight weeks before the day of the special election. Current law provides that the date for a special election may not be less than 62 nor more than 77 days from the date of the governor's order calling for the special election and that the primary must be held on the day that is four weeks before the day of the special election.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 5.02 (12n) "Overseas elector" means a U.S. citizen who is residing outside of
3 the United States, who is not disqualified from voting under s. 6.03, who has attained
4 or will attain the age of 18 by the date of an election at which the citizen proposes to
5 vote, who was last domiciled in this state or whose parent was last domiciled in this
6 state immediately prior to the parent's departure from the United States, and who
7 is not registered to vote or voting in any other state, territory, or possession.

8 **SECTION 2.** 5.02 (20) of the statutes is amended to read:

1 5.02 (20) “Special primary” means the primary held ~~4~~ 8 weeks before the
2 special election except when the special election is held on the same day as the
3 general election the special primary shall be held on the same day as the general
4 primary or if the special election is held concurrently with the spring election, the
5 primary shall be held concurrently with the spring primary.

6 **SECTION 3.** 5.05 (13) (c) of the statutes is amended to read:

7 5.05 (13) (c) The commission shall maintain a freely accessible system under
8 which a military elector, as defined in s. 6.34 (1) (a), or an overseas elector, ~~as defined~~
9 ~~in s. 6.34 (1) (b)~~, who casts an absentee ballot may ascertain whether the ballot has
10 been received by the appropriate municipal clerk.

11 **SECTION 4.** 5.05 (13) (d) 1. of the statutes is amended to read:

12 5.05 (13) (d) 1. To permit a military elector, as defined in s. 6.34 (1) (a), or an
13 overseas elector, ~~as defined in s. 6.34 (1) (b)~~, to request a voter registration
14 application or an application for an absentee ballot at any election at which the
15 elector is qualified to vote in this state.

16 **SECTION 5.** 6.22 (2) (b) of the statutes is amended to read:

17 6.22 (2) (b) A military elector shall make and subscribe to the certification
18 under s. 6.87 (2) before a witness who is an adult ~~U.S. citizen~~.

19 **SECTION 6.** 6.22 (2) (e) of the statutes is amended to read:

20 6.22 (2) (e) A military elector may file an application for an absentee ballot by
21 means of electronic mail or facsimile transmission in the manner prescribed in s. 6.86
22 (1) (ac). Upon receipt of a valid application, the municipal clerk shall send the elector
23 an absentee ballot or, if the elector is a military elector, as defined in s. 6.34 (1) (a),
24 and the elector so requests, shall transmit an absentee ballot to the elector by means

1 of electronic mail or facsimile transmission in the manner prescribed in s. 6.87 (3)
2 (d).

3 **SECTION 7.** 6.22 (4) (a) of the statutes is amended to read:

4 6.22 (4) (a) Upon receiving a timely request for an absentee ballot under par.
5 (b) by an individual who qualifies as a military elector, the municipal clerk shall send
6 or, if the individual is a military elector as defined in s. 6.34 (1) (a), shall transmit
7 to the elector upon the elector's request an absentee ballot for all elections that occur
8 in the municipality or portion thereof where the elector resides in the same calendar
9 year in which the request is received, unless the individual otherwise requests.

11 6.22 (4) (c) A military elector may indicate an alternate address on his or her
12 absentee ballot application. If the elector's ballot is returned as undeliverable prior
13 to the deadline for return of absentee ballots under s. 6.87 (6), and the elector remains
14 eligible to receive absentee ballots under this section, the municipal clerk shall
15 immediately send or, if the elector is a military elector as defined in s. 6.34 (1) (a),
16 transmit an absentee ballot to the elector at the alternate address.

18 6.24 (2) ELIGIBILITY. An overseas elector ~~under sub. (1)~~ may vote in any election
19 for national office, including the partisan primary and presidential preference
20 primary and any special primary or election. Such elector may not vote in an election
21 for state or local office unless the elector qualifies as a resident of this state under
22 s. 6.10. An overseas elector shall vote in the ward or election district in which the
23 elector was last domiciled or in which the elector's parent was last domiciled prior
24 to departure from the United States.

1 6.24 (4) (c) Upon receipt of a timely application from an individual who
2 qualifies as an overseas elector and who has registered to vote in a municipality
3 under sub. (3), the municipal clerk of the municipality shall send, or if the individual
4 is an overseas elector, ~~as defined in s. 6.34 (1) (b)~~, shall transmit an absentee ballot
5 to the individual upon the individual's request for all subsequent elections for
6 national office to be held during the year in which the ballot is requested, except as
7 otherwise provided in this paragraph, unless the individual otherwise requests or
8 until the individual no longer qualifies as an overseas elector of the municipality.
9 The clerk shall not send an absentee ballot for an election if the overseas elector's
10 name appeared on the registration list in eligible status for a previous election

13 ballot is clearly marked as not forwardable. If an overseas elector who files an
14 application under this subsection no longer resides at the same address that is

5 merchant marine, is absent from the residence where the member is otherwise
6 qualified to vote; or the spouse or dependent of any such member who, by reason of

18 the municipal clerk or deputy clerk to enter his or her initials indicating that if the
19 absentee elector voted in person under s. 6.86 (1) (ar), the elector presented proof of
20 identification to the clerk and the clerk verified the proof presented. The certificate
21 shall also include a space for the municipal clerk or deputy clerk to enter his or her
22 initials indicating that the elector is exempt from providing proof of identification
23 because the individual is a military elector or an overseas elector who does not

9 ** — An individual who serves as a witness for a military elector or an overseas
10 elector voting absentee, regardless of whether the elector qualifies as a resident of
11 this state under s. 6.10, Wis. Stats., need not be a U.S. citizen but must be 18 years
12 of age or older.

13 **_ — If this form is executed before 2 special voting deputies under s. 6.875 (6),

16 6.87 (3) (d) A municipal clerk shall, if the clerk is reliably informed by a military

18 regardless of whether the elector qualifies as a resident of this state under s. 6.10,

21 5.655 or a ballot used with an electronic voting system in a primary which is marked
22 for candidates of more than one party invalidates all votes cast by the elector for
23 candidates in the primary.

5 of an absent elector and must be opened in the same room where votes are being cast

8 absentee ballot canvassers under s. 7.52, stats.”. If the elector is a military elector,
9 as defined in s. 6.34 (1) (a), or an overseas elector, ~~as defined in s. 6.34 (1) (b)~~

11 and the ballot was received by the elector by facsimile transmission or electronic mail
12 and is accompanied by a separate certificate, the clerk shall enclose the ballot in a
13 certificate envelope and securely append the completed certificate to the outside of
14 the envelope before enclosing the ballot in the carrier envelope. The clerk shall keep
15 the ballot in the clerk’s office or at the alternate site, if applicable until delivered, as
16 required in sub. (2).

17 **SECTION 24.** 6.97 (1) of the statutes is amended to read:

18 6.97 (1) Whenever any individual who is required to provide proof of residence
19 under s. 6.34 in order to be permitted to vote appears to vote at a polling place and
20 cannot provide the required proof of residence, the inspectors shall offer the
21 opportunity for the individual to vote under this section. Whenever any individual,
22 other than a military elector, as defined in s. 6.34 (1) (a), or an overseas elector, as
23 ~~defined in s. 6.34 (1) (b),~~ or an elector who has a confidential listing under s. 6.47 (2),
24 appears to vote at a polling place and does not present proof of identification under
25 s. 6.79 (2), whenever required, the inspectors or the municipal clerk shall similarly

1 offer the opportunity for the individual to vote under this section. If the individual
2 wishes to vote, the inspectors shall provide the elector with an envelope marked
3 “Ballot under s. 6.97, stats.” on which the serial number of the elector is entered and
4 shall require the individual to execute on the envelope a written affirmation stating

7 giving the elector a ballot, write on the back of the ballot the serial number of the
8 individual corresponding to the number kept at the election on the poll list or other
9 list maintained under s. 6.79 and the notation “s. 6.97”. If voting machines are used
10 in the municipality where the individual is voting, the individual’s vote may be
11 received only upon an absentee ballot furnished by the municipal clerk which shall
12 have the corresponding number from the poll list or other list maintained under s.
13 6.79 and the notation “s. 6.97” written on the back of the ballot by the inspectors
14 before the ballot is given to the elector. When receiving the individual’s ballot, the
15 inspectors shall provide the individual with written voting information prescribed
16 by the commission under s. 7.08 (8). The inspectors shall indicate on the list the fact
17 that the individual is required to provide proof of residence or proof of identification
18 under s. 6.79 (2) but did not do so. The inspectors shall notify the individual that he
19 or she may provide proof of residence or proof of identification to the municipal clerk
20 or executive director of the municipal board of election commissioners. The
21 inspectors shall also promptly notify the municipal clerk or executive director of the
22 name, address, and serial number of the individual. The inspectors shall then place
23 the ballot inside the envelope and place the envelope in a separate carrier envelope.

1 7.15 (1) (cm) Prepare official absentee ballots for delivery to electors requesting
2 them, and except as provided in this paragraph, send an official absentee ballot to
3 each elector who has requested a ballot by mail, and to each military elector, as
4 defined in s. 6.34 (1) (a), and overseas elector, ~~as defined in s. 6.34 (1) (b)~~, who has
5 requested a ballot by mail, electronic mail, or facsimile transmission no later than
6 the 47th day before each partisan primary and general election and no later than the
7 21st day before each other primary and election if the request is made before that
8 day; otherwise, the municipal clerk shall send or transmit an official absentee ballot
9 within one business day of the time the elector's request for such a ballot is received.
10 The clerk shall send or transmit an absentee ballot for the presidential preference

12 before the presidential preference primary if the request is made before that day, or,
13 if the request is not made before that day, within one business day of the time the
14 request is received. For purposes of this paragraph, "business day" means any day
15 from Monday to Friday, not including a legal holiday under s. 995.20.

17 7.15 (1) (j) Send an absentee ballot automatically to each elector and send or
18 transmit an absentee ballot to each military elector, as defined in s. 6.34 (1) (a), and

20 therefor in accordance with s. 6.22 (4), 6.24 (4) (e), or 6.86 (2) or (2m).

10 partisan primary or if the special election is held concurrently with the spring
11 election, the primary shall be held concurrently with the spring primary, and except
12 when the special election is held on the Tuesday after the first Monday in November
13 of an odd-numbered year, the primary shall be held on the 2nd Tuesday of August
14 in that year.

15 **SECTION 28.** 8.50 (4) (d) of the statutes is repealed and recreated to read:
