**SENATE AMENDMENT 1,
TO SENATE BILL 329**

September 26, 2017 - Offered by Senators DARLING and LARSON.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 1, line 3: after “teachers,” insert “pupil service professionals,”.
- 3 **2.** Page 2, line 8: after that line insert:
- 4 “**SECTION 2m.** 20.255 (2) (fh) of the statutes, as created by 2017 Wisconsin Act
- 5 this act, is repealed.”.
- 6 **3.** Page 2, line 12: after “teachers,” insert “pupil service professionals,”.
- 7 **4.** Page 2, line 14: after “education.” insert “In awarding grants under this
- 8 section, the department shall give preference to school districts that have not applied
- 9 for a grant under this section in a prior school year.”.
- 10 **5.** Page 2, line 15: delete lines 15 to 18.
- 11 **6.** Page 2, line 20: after that line insert:

1 **“SECTION 3m.** 115.413 of the statutes, as created by 2017 Wisconsin Act this
2 act, is repealed.”.

3 **7.** Page 2, line 21: after “statutes” insert “, as affected by 2017 Wisconsin Act
4 59, ”.

5 **8.** Page 3, line 1: delete the material beginning with that line and ending with
6 “and (38),” on page 3, line 7, and substitute:

5 the terms of a contract, to the commissioner or to any school transferred to an
6 opportunity schools and partnership program.

7 **SECTION 5m. Effective dates.** This act takes effect on the day after
8 publication, except as follows:

9 (1) The treatment of section 119.04 (1) (by SECTION 4m) and the repeal of
10 sections 20.255 (2) (fh) and 115.413 of the statutes take effect on the first day of the
11 25th month after publication.”.
