**ASSEMBLY AMENDMENT 2,
TO SENATE BILL 76**

April 5, 2017 - Offered by Representative MASON.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 4, line 23: after that line insert:

3 “**SECTION 3m.** 281.34 (7) (title) of the statutes is amended to read:

4 281.34 **(7)** (title) ~~MODIFYING AND RESCINDING~~ DURATION, MODIFICATION, AND
5 RESCISSION OF APPROVALS FOR HIGH CAPACITY WELLS.

6 **SECTION 3n.** 281.34 (7) of the statutes is renumbered 281.34 (7) (b) (intro.) and
7 amended to read:

8 281.34 **(7)** (b) (intro.) The An approval of a high capacity well issued under this
9 section or under s. 281.17 (1), 2001 stats., prior to the effective date of this paragraph
10 [LRB inserts date], remains in effect for the following periods unless the
11 department modifies or rescinds the approval because the high capacity well or the
12 use of the high capacity well is not in conformance with standards or conditions
13 applicable to the approval of the high capacity well.:

1 **SECTION 3o.** 281.34 (7) (a) of the statutes is created to read:

2 281.34 (7) (a) An approval of a high capacity well issued under this section on
3 or after the effective date of this paragraph [LRB inserts date], may not remain
4 in effect for more than 10 years and may be modified or rescinded because the high
5 capacity well or the use of the high capacity well is not in conformance with standards
6 or conditions applicable to the approval of the high capacity well.

7 **SECTION 3s.** 281.34 (7) (b) 1. to 5. of the statutes are created to read:

8 281.34 (7) (b) 1. For an approval of a high capacity well issued before January
9 1, 1980, 8 years from the effective date of this subdivision [LRB inserts date].

10 2. For an approval of a high capacity well issued on or after January 1, 1980,
11 and before January 1, 1990, 10 years from the effective date of this subdivision
12 [LRB inserts date].

13 3. For an approval of a high capacity well issued on or after January 1, 1990,
14 and before January 1, 2000, 12 years from the effective date of this subdivision
15 [LRB inserts date].

16 4. For an approval of a high capacity well issued on or after January 1, 2000,
17 and before January 1, 2010, 14 years from the effective date of this subdivision
18 [LRB inserts date].

19 5. For an approval of a high capacity well issued on or after January 1, 2010,
20 and before the effective date of this subdivision [LRB inserts date], 16 years from
21 the effective date of this subdivision [LRB inserts date].”.

22 **2.** Page 9, line 23: delete “sub. (7)” and substitute “sub. (7) (b)”.
