ORDER

An order of the Funeral Directors Examining Board to repeal FD 2.10 (3); to amend FD 2.04; to repeal and recreate FD 2.10 (2); and to create FD 2.13, relating to discrimination, sanitation and confidentiality.

Analysis prepared by the Department of Regulation and Licensing.

<u>ANALYSIS</u>

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11, 445.03 (1) (b) and (2) (a), Stats.

Statutes interpreted: s. 445.03 (1) (b) and (2) (a), Stats.

In this proposed rule-making order the Funeral Directors Examining Board amends s. FD 2.04 to make clear that the prohibition on discrimination in the provision of funeral goods and services extends to discrimination based upon HIV status or sexual orientation.

Section FD 2.10 preceded the Occupational Safety and Health Administration (OSHA) requirements for occupational exposure to blood borne pathogens. The revision updates the sanitation requirements to recognize the existence of federal standards that apply to the industry.

The newly created s. FD 2.13 preserves as a separate section the language on confidentiality currently found in s. FD 2.10 (3) (a).

TEXT OF RULE

SECTION 1. FD 2.04 is amended to read:

FD 2.04 <u>DISCRIMINATION</u>. No funeral director licensed in Wisconsin, or apprentice funeral director holding a certificate of apprenticeship in this state, or person holding a funeral establishment permit herein, shall deny services or the use of <u>an</u> establishment to any person because of race, color, creed, national origin or ancestry; <u>HIV infection</u>, or sexual orientation; provided, however, that this <u>rule section</u> shall not apply where a funeral establishment is, for religious reasons, so operated that its services are provided to members of only one religious faith.

SECTION 2. FD 2.10 (2) is repealed and recreated to read:

FD 2.10 (2) All post-mortem procedures shall be performed and all preparation rooms, equipment, instruments and supplies in funeral establishments shall be maintained in compliance with the terms and conditions set forth in the occupational safety and health administration requirements for occupational exposure to blood borne pathogens. In cases of HIV infection, after the body has been prepared in accordance with s. HSS 136.04, the usual and customary procedures may be followed for restoration and cosmetology. Following embalming and body preparation, no special precautions need to be observed during visitation

SECTION 3. FD 2.10 (3) is repealed.

SECTION 4. FD 2.13 is created to read:

FD 2.13 <u>CONFIDENTIALITY</u>. All personnel involved in the post-mortem care of the deceased shall be informed of the confidentiality provisions under s. 252.15 (5), Stats., and the consequences of violating these confidentiality provisions.
