## ANALYSIS BY THE DEPARTMENT OF PUBLIC INSTRUCTION

Statutory authority: ss. 227.11 (2) (a) and 227.16 (2) (b), Stats.

Statute interpreted: ss. 39.41 (8), 1991-92 Stats.; 115.28 (21), 1995-96 Stats.; 115.28 (35), 1995-96 Stats.; 115.28 (38), 1995-96 Stats.

The department proposes to repeal the following rule chapters because of the elimination or modification of statutory language relating to these chapters:

- Chapter PI 23, relating to the youth initiatives program. This chapter will be repealed since the youth initiatives program under s. 115.28 (21), Stats., was eliminated June 30, 1996, pursuant to 1995 Wisconsin Act 27.
- Chapter PI 33, relating to academic excellence higher education scholarships. This chapter will be repealed since the program is no longer required by statute to be jointly implemented by both the Higher Educational Aids Board (HEAB) and the department. Section 39.41, Stats, pursuant to 1993 Wisconsin Act 457, requires the program to be implemented by HEAB only.
- Chapter PI 39, relating to collaborative projects. This chapter will be repealed since the grants for collaborative projects under s. 115.28 (35), Stats., was eliminated June 30, 1996, pursuant to 1995 Wisconsin Act 27.
- Chapter PI 43, relating to reporting of pupils attending technical college districts. This chapter will be repealed since the reporting requirement under s. 115.28 (38), Stats., was eliminated pursuant to 1995 Wisconsin Act 27.

The elimination of these chapters is technical because the statutes no longer exist for the rule to interpret or implement. Therefore, pursuant to s. 227.16 (2) (b), Stats., the department will not hold public hearings regarding these rules. The department no longer collects information, requires data, or distributes funds that are affected by these rule chapters. Therefore, an initial applicability clause is not necessary.

**SECTION 1.** Chapter PI 23 is repealed.

**SECTION 2.** Chapter PI 33 is repealed.

**SECTION 3.** Chapter PI 39 is repealed.

**SECTION 4.** Chapter PI 43 is repealed.

The rules contained in this order shall take effect on the first day of the month commencing after the date of publication in the Wisconsin Administrative Register, as provided in s. 227.22(2)(intro.), Stats.
