

EXECUTIVE ORDER #69

WHEREAS, effective employment and job training programs are essential elements of Wisconsin's economic development policy and plan; and

WHEREAS, federal government policy and planning has clearly emphasized the role and responsibility of states in designing and administering employment and job training programs; and

WHEREAS, consistent employment and training policy direction and management should allocate resources according to priorities, minimize redundancy among programs and encourage appropriate specialization and coordination among programs; and

WHEREAS, the employment and training programs of the Department of Industry, Labor and Human Relations include the Job Service, the public labor exchange, the state apprenticeship program, the equal rights and labor standards program, worker safety programs, and the state's program for labor market information production and distribution; and

WHEREAS, the Secretary of the Department of Industry, Labor and Human Relations serves ex officio on the State Board of Vocational, Technical and Adult Education, as well as serving on the Customized Labor Training Fund Board, the Wisconsin Economic Adjustment Council and the State Job Training Coordinating Council; and

WHEREAS, said boards and councils also include as members the Lieutenant Governor who also serves as the Secretary of the Department of Development, the Superintendent of the Department of Public Instruction, the Director of the State Board of Vocational, Technical and Adult Education, and the Secretary of the Department of Health and Social Services; and

WHEREAS, at my direction, the Secretary of the Department of Industry, Labor and Human Relations has supervised the Executive Director of the Governor's Employment and Training Office and that agency's programs under the Job Training Partnership Act since June, 1984 as an initial step in a major restructuring and reorganization of employment and job training programs administered by the Governor's Employment and Training Office and the Department of Industry, Labor and Human Relations; and

WHEREAS, full implementation of the said reorganization of the Governor's Employment and Training Office in the Department of Industry, Labor and Human Relations requires legislative implementation; and

WHEREAS, the Secretary of the Department of Industry, Labor and Human Relations is by virtue of these various responsibilities uniquely positioned to know and influence the course of the employment and training programs entrusted, not only to the Department of Industry, Labor and Human Relations, but also the Governor's Employment and Training Office, and the aforesaid boards and councils;

NOW, THEREFORE, I, ANTHONY S. EARL, Governor of the State of Wisconsin, do hereby order and direct that Howard S. Bellman, Secretary of the Department of Industry, Labor and Human Relations, develop a consistent policy framework for coordinated state employment and training programs, including the programs of all state agencies; and provide leadership among the cabinet to ensure compatibility among said programs; by the following measures;
