



1995 ASSEMBLY BILL 685

November 21, 1995 - Introduced by LAW REVISION COMMITTEE. Referred to Committee on Rules.

1 **AN ACT relating to:** amending various provisions of the statutes for the purpose
2 of correcting errors (Revisor's Correction Bill).

Analysis by the Legislative Reference Bureau

This revisor's correction bill is explained in the NOTES provided by the revisor of statutes bureau in the bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 1.** 5.02 (23) of the statutes, as affected by 1995 Wisconsin Act 27,
4 section 9145 (1) (c), is amended to read:

5 5.02 (23) "State office" means the offices of governor, lieutenant governor,
6 secretary of state, state treasurer, attorney general, ~~secretary of education~~ state
7 superintendent, justice of the supreme court, court of appeals judge, circuit court
8 judge, state senator, state representative to the assembly and district attorney.

NOTE: Reinserts language unintentionally replaced by 1995 Wis. Act 27, section 9145 (1) (c). That section provides, with limited exceptions inapplicable to this provision, that all references in the statutes to "state superintendent of public instruction" are changed to "secretary of education". However: a) article X, section 1, of the constitution requires the election of the state superintendent; b) section 177m of 1995 Wis. Act 27, which creates the position of secretary of education, provides for filling that position by appointment; and c) the Budget Analysis states that the secretary of education is "nominated by the governor and appointed with the advice and consent of the senate".

1 **SECTION 2.** 5.02 (24) of the statutes, as affected by 1995 Wisconsin Act 27,
2 section 9145 (1) (c), is amended to read:

3 5.02 (24) “State superintendent” means the ~~secretary of education~~ state
4 superintendent.

5 **SECTION 3.** 5.58 (2) (title) of the statutes, as affected by 1995 Wisconsin Act 1995
6 Wisconsin Act 27, section 9145 (1) (c), is amended to read:

7 5.58 (2) (title) ~~SECRETARY OF EDUCATION~~ STATE SUPERINTENDENT OF PUBLIC
8 INSTRUCTION; JUDICIARY; COUNTY EXECUTIVE; AND COUNTY SUPERVISORS.

9 **SECTION 4.** 5.58 (2) (a) of the statutes, as affected by 1995 Wisconsin Act 27,
10 section 9145 (1) (c), is amended to read:

11 5.58 (2) (a) There shall be one separate ballot for state superintendent, judicial
12 officers, county executive under s. 59.031 and county supervisor. In counties having
13 a population of 500,000 or more, the ballot also shall include those offices under s.
14 8.11 (2) and (2m). The arrangement of names of candidates for state superintendent,
15 justice, court of appeals judge and circuit court judge shall be determined by the
16 board in the manner specified in s. 5.60 (1) (b). Arrangement of the names of
17 candidates for county executive and county supervisor shall be determined by the
18 county clerk or by the executive director of the county board of election
19 commissioners in the manner specified in s. 5.60 (1) (b). The ballot shall be titled
20 “Official Ballot for ~~Secretary of Education~~ State Superintendent of Public
21 Instruction, Judicial, County Executive and County Supervisor Primary”.
