## **1995 SENATE BILL 111**

- March 15, 1995 Introduced by Senators DRZEWIECKI, FARROW, COWLES, DARLING, PANZER, SCHULTZ and FITZGERALD, cosponsored by Representatives WALKER, JENSEN, HANSON, PORTER, TRAVIS, SCHNEIDERS, MUSSER, JOHNSRUD, OURADA, BOYLE, OTT, DUFF, AINSWORTH, FREESE, HAHN, VRAKAS, KREIBICH, LADWIG, LAZICH, SERATTI, WARD, GUNDERSON, HOVEN and OLSEN. Referred to Committee on State Government Operations and Corrections.
- 1 AN ACT to amend 59.997 (7) of the statutes; relating to: adjustment of the date

#### 2 of the 1996 spring primary and election and presidential preference primary

3 and certain other dates for election procedures.

#### Analysis by the Legislative Reference Bureau

This bill changes the date of the 1996 spring primary from the 3rd Tuesday in February to the first Tuesday in February, and the date of the 1996 spring election and presidential preference primary from the first Tuesday in April to the 3rd Tuesday in March. The bill also changes certain other related dates for the performance of acts related to the 1996 spring primary and election or established to coordinate with the dates of the 1996 spring primary and election.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 4 **SECTION 1.** 59.997 (7) of the statutes is amended to read:
- 5 59.997 (7) When the publication of the said consolidation agreement in each of
