

1995 SENATE BILL 544

- February 14, 1996 Introduced by Senator GROBSCHMIDT, cosponsored by Representatives BRANCEL, TURNER, JENSEN, HASENOHRL, ALBERS and BRANDEMUEHL. Referred to Committee on Transportation, Agriculture and Local Affairs.
- 1 AN ACT to amend 59.97 (4d) (title), 60.61 (3c) (title) and 62.23 (7) (he) (title); and
- 2 *to create* 59.97 (4dm), 60.61 (3d) and 62.23 (7) (hf) of the statutes; **relating to:**
- 3 the regulation of certain amateur radio antennas by cities, villages, towns and
- 4 counties.

Analysis by the Legislative Reference Bureau

This bill restricts the ability of counties, cities, towns and villages (a political subdivision) to regulate the placement, screening or height of amateur radio antennas. Under the bill, a political subdivision may not enact an ordinance or adopt a resolution on or after the effective date of the bill, or continue to enforce an ordinance or resolution on or after the effective date of the bill, that involves the placement, screening or height of amateur radio antennas unless the ordinance or resolution is reasonably crafted to address a specific health or safety concern. Under the bill a political subdivision may not enact an ordinance or adopt a resolution, or continue to enforce an ordinance or resolution, after the effective date of the bill, if the ordinance or resolution is based solely on aesthetic considerations.

14	SECTION 4. 60.61 (3d) of the statutes is created to read:
15	60.61 (3d) AMATEUR RADIO ANTENNA FACILITIES. The town board may not enact
16	an ordinance or adopt a resolution on or after the effective date of this subsection
17	[revisor inserts date], or continue to enforce an ordinance or resolution on or after the
18	effective date of this subsection [revisor inserts date], that involves the placement,
19	screening or height of amateur radio antennas unless the ordinance or resolution is
20	reasonably crafted to address a specific health or safety concern. The town board
21	may not enact an ordinance or adopt a resolution on or after the effective date of this
22	subsection [revisor inserts date], or continue to enforce an ordinance or resolution
23	on or after the effective date of this subsection [revisor inserts date], that involves
24	the placement, screening or height of amateur radio antennas, if the ordinance or
25	resolution is based solely on aesthetic considerations.
