## **1999 SENATE BILL 509**

March 23, 2000 – Introduced by JOINT COMMITTEE ON EMPLOYMENT RELATIONS. Referred to Committee on Senate Organization.

1 AN ACT relating to: ratification of the agreement negotiated between the state 2 of Wisconsin and the Wisconsin Professional Employes Council, WFT/AFT, 3 AFL-CIO, for the 1999-2001 biennium, covering employes in the professional 4 fiscal and staff services collective bargaining unit, and authorizing an 5 expenditure of funds.

### Analysis by the Legislative Reference Bureau

This proposal is introduced under section 111.92 (1) of the statutes. The proposal ratifies the collective bargaining contract for state employes in the professional fiscal and staff services collective bargaining unit negotiated for the 1999–2001 biennium under the state employment labor relations act. Currently, statutory program supplement appropriations fund the costs of collective bargaining agreements to the extent that they exceed budgeted costs. The proposal authorizes expenditure of moneys from those appropriations to fund the cost of this agreement.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

1999 – 2000 Legislature

#### **SENATE BILL 509**

**SECTION 1. Agreement ratified.** The legislature ratifies the tentative 1  $\mathbf{2}$ agreement negotiated for the 1999-2001 biennium between the state of Wisconsin. 3 department of employment relations, and the Wisconsin Professional Employes Council, WFT/AFT, AFL-CIO, covering employes in the professional fiscal and staff 4 services collective bargaining unit under subchapter V of chapter 111 of the statutes,  $\mathbf{5}$ 6 as approved by the employes of the professional fiscal and staff services collective 7 bargaining unit and approved and recommended by the joint committee on 8 employment relations, and authorizes the necessary expenditure of moneys for 9 implementation from the appropriations made by section 20.865 (1) of the statutes. subject to section 20.865 (intro.) of the statutes. The secretary of employment 10 11 relations shall file an official copy of the agreement, certified by the cochairpersons 12of the joint committee on employment relations, with the secretary of state. No formal or informal agreement between the parties which is not a part of the official 1314 copy is deemed to be approved by the legislature under this act.

### **SECTION 2. Effective date.**

(1) This act takes effect on the day following publication, except that those
provisions specifically identified as having other effective dates in the agreement
covering employes in the professional fiscal and staff services collective bargaining
unit are effective on the dates provided in that agreement.
