



2001 ASSEMBLY BILL 269

March 30, 2001 – Introduced by Representatives GUNDERSON, JOHNSRUD, NASS, WADE, KREUSER, MUSSER, LIPPERT, OLSEN, D. MEYER, BERCEAU, HOVEN, KESTELL, TOWNSEND, KRAWCZYK, GUNDRUM and POWERS, cosponsored by Senators A. LASEE and LAZICH. Referred to Committee on Natural Resources.

- 1 **AN ACT to amend** 29.561 (1), 29.563 (14) (bn) and 29.563 (14) (c) 5. of the statutes;
2 **relating to:** deer hunting back tag number reservation fees.

Analysis by the Legislative Reference Bureau

Under current law, the department of natural resources (DNR) reserves a deer hunting back tag (back tag) number for a person who pays a reservation fee. Each year, upon payment of the fee, DNR issues the same back tag number to that person. Under current law, a person must pay a reservation fee for a back tag number of \$4.50 together with an issuing fee of 50 cents.

This bill provides that a person is required to pay only a one-time fee for a reservation for a back tag number. Once the fee is paid, DNR must issue the same back tag number to that person each year upon that person's request at no charge. The bill does not change the amount of the fee that a person must pay for the reservation.

9 addition to each reservation fee, an issuing fee of 50 cents.
