2001 SENATE BILL 325

November 21, 2001 – Introduced by Senator DECKER, cosponsored by Representatives GUNDERSON, LASSA, FREESE, PLOUFF, POCAN, BOCK, GRONEMUS and SYKORA. Referred to Committee on Universities, Housing, and Government Operations.

AN ACT *to create* 20.285 (1) (kj), 20.505 (8) (hm) 17c. and 36.25 (17) of the statutes; **relating to:** a grazing education grant program and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill establishes a program, administered by the University of Wisconsin-Extension, to make grants for educational and technical assistance concerning management intensive grazing. The grant program is funded with Indian gaming receipts. The program ends on June 30, 2006.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
