2003 SENATE BILL 495

February 26, 2004 – Introduced by Senators Lassa and Kanavas, cosponsored by Representatives Suder, Gronemus, Berceau, J. Lehman and Kreibich. Referred to Committee on Education, Ethics and Elections.

- 1 AN ACT to amend 119.04 (1); and to create 115.28 (52) and 118.46 of the statutes;
- 2 **relating to:** prohibiting pupils who take prohibited substances or engage in
- 3 certain practices from participating in interscholastic athletics.

Analysis by the Legislative Reference Bureau

This bill requires the Department of Public Instruction to develop and distribute to school boards a list of prohibited substances (other than controlled substances, tobacco, and alcohol) that are harmful to athletes. The bill requires each school board to prohibit a pupil who uses any of these substances, engages in blood doping or gene doping, or uses products that enhance the uptake, transport, or delivery of oxygen, from participating in at least one game or match of each interscholastic sport in which the pupil participates. "Blood doping" is defined in the bill as the use of blood, red blood cells, or red blood cell products to raise the capacity of blood to carry oxygen. "Gene doping" is defined in the bill as the use of genes, genetic elements, or cells in order to enhance athletic performance.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- **SECTION 1.** 118.46 of the statutes is created to read:
- 5 118.46 Interscholastic athletics; prohibited substances and practices.
- 6 (1) In this section:

(a) "Blood doping" means the use of autologous, homologous, or heterologous
blood, red blood cells, or red blood cell products of any origin in order to raise the
capacity of blood to carry oxygen.

- (b) "Gene doping" means the use of genes, genetic elements, or cells in order to enhance athletic performance.
- (2) By 6 months after the effective date of this subsection [revisor inserts date], the department shall develop and distribute to each school board a list of substances other than controlled substances, tobacco, and alcohol that are harmful to athletes.
- (3) Except as provided in sub. (4), beginning on the first day of the 8th month beginning after the effective date of this subsection [revisor inserts date], the school board shall prohibit a pupil who does any of the following from participating in at least one game or match of each interscholastic sport in which the pupil participates:
 - (a) Uses a prohibited substance on the list under sub. (2).
 - (b) Engages in blood doping or gene doping.
 - (c) Uses products that enhance the uptake, transport, or delivery of oxygen.
- (4) This section does not apply if the pupil is using a prohibited substance or product, or engaging in blood doping or gene doping, for legitimate medical treatment at the direction of a physician.
