2003 SENATE BILL 562

April 14, 2004 – Introduced by LAW REVISION COMMITTEE. Referred to Committee on Homeland Security, Veterans and Military Affairs and Government Reform.

1	AN ACT relating to: amending and revising sections 961.41 $\left(2\right)$ (bm) and 961.41
2	(2) (cm) of the statutes for the purpose of reconciling conflicts and supplying
3	omissions. (Revisor's Correction Bill).

Analysis by the Legislative Reference Bureau

This revisor's correction bill is explained in the NOTES provided by the revisor of statutes in the body of the bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 4 **SECTION 1.** 961.41 (2) (bm) of the statutes is amended to read:
- 5 961.41 (2) (bm) <u>Counterfeit of phencyclidine and certain other drugs.</u> A If a
- 6 person violates this subsection with respect to a counterfeit substance that is a
- 7 counterfeit of phencyclidine, methamphetamine, lysergic acid diethylamide,
- 8 gamma-hydroxybutyric acid, gamma-butyrolactone,

9	with respect to a counterfeit substance which that is flunitrazepam, the person is
10	punishable by subject to the applicable fine and imprisonment for manufacture,
11	distribution, delivery, or possession with intent to manufacture, distribute, or
12	deliver, of the genuine controlled substance under sub. (1) or (1m).
