- and fishing license fees paid by a minor child of a Wisconsin resident.

Analysis by the Legislative Reference Bureau

Currently, persons who are residents of this state, armed forces members who are stationed in this state, undergraduate students who are attending a college or university in this state, and citizens of foreign countries who are attending a high school in this state or an agricultural short course at the University of Wisconsin pay the same resident fee for hunting and fishing approvals.

This bill will allow the nonresident child of a resident to pay the same fee for hunting approvals and fishing licenses as a resident.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

29.563 (3) FISHING APPROVALS. (intro.) The Except as provided in sub. (3m), the
fees for fishing approvals are as follows:
Section 4. 29.563 (3m) of the statutes is created to read:
29.563 (3m) Fishing approvals for certain nonresidents. The fees for fishing
licenses for a 16 or 17 year-old who is not a resident and who exhibits proof that his
or her parent is a resident shall be the same as the fees for fishing licenses for
residents under sub. (3) (a).
