# 2005 SENATE BILL 280

August 10, 2005 – Introduced by Senators Lassa, WIRCH, ROESSLER and HANSEN, cosponsored by Representatives Suder, Molepske, Berceau, Lehman, Kreibich, Albers, Townsend, Ott and Gundrum. Referred to Committee on Education.

1 AN ACT *to amend* 119.04 (1); and *to create* 118.46 of the statutes; **relating to:** 2 prohibiting pupils who take prohibited substances or engage in certain 3 practices from participating in interscholastic athletics.

## Analysis by the Legislative Reference Bureau

This bill requires the Department of Public Instruction to develop and distribute to school boards a list of prohibited substances (other than controlled substances, tobacco, and alcohol) that are harmful to athletes. The bill requires each school board to prohibit a pupil who uses any of these substances, engages in blood doping or gene doping, or uses products that enhance the uptake, transport, or delivery of oxygen from participating in at least one game or match of each interscholastic sport in which the pupil participates. "Blood doping" is defined in the bill as the use of blood, red blood cells, or red blood cell products to raise the capacity of blood to carry oxygen. "Gene doping" is defined in the bill as the use of genes, genetic elements, or cells to enhance athletic performance.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 118.46 of the statutes is created to read:

5 **118.46 Interscholastic athletics; prohibited substances and practices.**

4	(b) "Gene doping" means the use of genes, genetic elements, or cells to enhance

6	(2) By 6 months after the effective date of this subsection [revisor inserts
7	date], the department shall develop and distribute to each school board a list of
8	substances, other than controlled substances, tobacco, and alcohol, that are harmful
9	to athletes.
10	(3) Except as provided in sub. (4), beginning on the first day of the 8th month
11	beginning after the effective date of this subsection [revisor inserts date], the
12	school board shall prohibit a pupil who does any of the following from participating
13	in at least one game or match of each interscholastic sport in which the pupil
14	participates:
15	(a) Uses a prohibited substance on the list under sub. (2).
16	(b) Engages in blood doping or gene doping.
17	(c) Uses products that enhance the uptake, transport, or delivery of oxygen.
18	(4) This section does not apply if the pupil is using a prohibited substance or
19	product, or engaging in blood doping or gene doping, for legitimate medical
20	treatment at the direction of a physician.
