2007 ASSEMBLY BILL 940

March 11, 2008 – Introduced by Representatives Vos, Kerkman and Lothian. Referred to Committee on Education.

1 AN ACT *to amend* 119.04 (1) and 119.44 (2) (c); and *to create* 120.12 (27) and 2 120.18 (1) (h) of the statutes; **relating to:** requiring school districts to spend at 3 least 70 percent of their operating expenses on direct classroom expenditures.

Analysis by the Legislative Reference Bureau

This bill requires each school district to spend at least 70 percent of its operating expenditures in each school year on direct classroom expenditures. If a school district fails to do so in any school year, it must increase the amount spent on direct classroom expenditures by two percent in each succeeding school year until the 70 percent level is reached.

10	120.12 (27) CLASSROOM EXPENDITURES. (a) In this section, "direct classroom
11	expenditures" means expenditures for salaries and benefits of teachers and teacher
12	aides, instructional supplies, tuition, athletic programs, and cocurricular activities.
13	(b) Annually spend at least 70 percent of the school district's total operating
14	expenditures on direct classroom expenditures. If in any school year a school board
15	spends a lower percentage, it shall increase the percentage spent on direct classroom
16	expenditures by at least 2 percent each succeeding school year until the 70 percent
17	level is attained.
18	SECTION 4. 120.18 (1) (h) of the statutes is created to read:
19	120.18 (1) (h) The percentage of the school district's total operating
20	expenditures that were spent during the school year on direct classroom
21	expenditures, as defined in s. 120.12 (27) (a).
