



## 2007 ASSEMBLY RESOLUTION 17

March 5, 2008 – Introduced by COMMITTEE ON RULES.

1     **Relating to:** establishing special orders of business for Tuesday, March 11, 2008.

2             *Resolved by the assembly, That:*

**SECTION 1. Special order scheduled.** The following proposals shall be special orders of business on Tuesday, March 11, 2008, at the times shown:

- (1) At 11:01 a.m., 2007 Assembly Bill 482, relating to: prohibiting the Milwaukee Public Schools from imposing residency requirements on teachers.
- (2) At 11:02 a.m., 2007 Assembly Bill 668, relating to: membership of the group insurance board.
- (3) At 11:03 a.m., 2007 Assembly Bill 685, relating to: parenting plans in actions affecting the family.
- (4) At 11:04 a.m., 2007 Assembly Bill 688, relating to: the definition of a late enrollee; making group insurance certificates available electronically; prohibiting a lender from requiring property insurance in an amount that exceeds the replacement value of improvements; premium tax statute of limitations; miscellaneous changes to the insurance security fund; investments of the local government property insurance fund by the State of Wisconsin Investment Board, other miscellaneous insurance-related modifications; and granting rule-making authority.
- (5) At 11:05 a.m., 2007 Assembly Bill 709, relating to: requiring every applicant for a marriage license to present a certified copy of a birth certificate.

- (6) At 11:06 a.m., 2007 Assembly Bill 735, relating to: petitions and management plans for the designation of managed forest land, transferrals of ownership of managed forest land, establishing stumpage values and estimating withdrawal taxes under the managed forest land program, signatures and authentication requirements for orders under the forest croplands program, granting rule-making authority, and making an appropriation.
- (7) At 11:07 a.m., 2007 Assembly Bill 745, relating to: prohibiting the retention of certain information obtained in transactions using account access devices.
- (8) At 11:08 a.m., 2007 Assembly Bill 765, relating to: certain review, reporting, and out-of-date requirements regarding the Public Service Commission (suggested as remedial legislation by the Public Service Commission).
- (9) At 11:09 a.m., 2007 Assembly Bill 769, relating to: placement of a child for adoption with a nonrelative prior to termination of parental rights, payment for preadoption preparation when a child is placed for adoption by a child welfare agency, and the applicability of the Interstate Compact on the Placement of Children.
- (10) At 11:10 a.m., 2007 Assembly Bill 798, relating to: the sale of raffle tickets.
- (11) At 11:11 a.m., 2007 Assembly Bill 803, relating to: exempting nonprofit camps from certain town sanitary district or town assessments.
- (12) At 11:12 a.m., 2007 Assembly Bill 807, relating to: the definition of a group health benefit plan and reports by the commissioner of insurance on the effect of changing the definition.

- (19) At 11:19 a.m., 2007 Assembly Bill 893, relating to: distribution of moneys to Wisconsin Retirement System employers under 1999 Wisconsin Act 11; payment of interest by the Department of Employee Trust Funds on credited or refunded moneys; Wisconsin Retirement System beneficiary standard sequence; accelerated death benefit option continuation under the Wisconsin Retirement System; life insurance benefits administered by the Department of Employee Trust Funds; definition of the term Internal Revenue Code for purposes of benefit plans administered by the Department of Employee Trust Funds; interest rates charged on moneys owed the Department of Employee Trust Funds for benefit programs; payment of death benefits under the Wisconsin Retirement System; authority of the Group Insurance Board; eligibility requirements for duty disability benefit under the Wisconsin Retirement System; amortization period for unfunded prior service liability under the Wisconsin Retirement System; attachment of retirement benefits for delinquent state tax purposes; waiver of benefits under the Wisconsin Retirement System; and granting rule-making authority.
- (20) At 11:20 a.m., 2007 Assembly Bill 898, relating to: police escorts and vehicle rights-of-way related to escorted vehicles and providing a penalty.
- (21) At 11:21 a.m., 2007 Senate Bill 49, relating to: free access to state parks and state trails by certain disabled veterans and former prisoners of war.
- (22) At 11:22 a.m., 2007 Senate Bill 72, relating to: ratification of the Midwest Interstate Passenger Rail Compact.
- (23) At 11:23 a.m., 2007 Senate Bill 86, relating to: a fraud, waste, and mismanagement hotline at the Legislative Audit Bureau.
- (24) At 11:24 a.m., 2007 Senate Bill 142, relating to: requirements to successfully complete training on use of an automated external defibrillator, extending the time limit for emergency rule procedures, providing an exemption from emergency rule procedures, and requiring the exercise of rule-making authority.
