2015 ASSEMBLY BILL 547

November 24, 2015 – Introduced by Representatives Steffen, E. BROOKS, GANNON, KAHL, KREMER, KRUG, KUGLITSCH, T. LARSON, MURPHY, NOVAK, PETERSEN, PETRYK, RIPP, SCHRAA, TAUCHEN, TITTL, WEATHERSTON, ZEPNICK and MACCO, cosponsored by Senators WANGGAARD, COWLES, GUDEX and LASEE. Referred to Committee on Energy and Utilities.

AN ACT *to create* 943.01 (2k) and 943.143 of the statutes; **relating to:** trespass and damage to property owned or used by an energy provider and providing a criminal penalty.

Analysis by the Legislative Reference Bureau

This bill increases the criminal penalty for intentionally damaging property from a Class A misdemeanor to a Class H felony if the property damaged is owned, leased, or operated by an energy provider and the actor intended to, or did, cause a substantial interruption of the energy provider's goods or services.

Under the bill, entering a property that is part of an energy plant or electric generation, distribution, or transmission system or part of a natural gas distribution system without lawful authority or the consent of the energy provider that owns, operates, or leases the property is also a Class H felony.

 (b) "Energy provider property" means property that is part of an electric
 generation, distribution, or transmission system or part of a natural gas distribution
 system and that is owned, leased, or operated by an energy provider.
 (2) Whoever intentionally enters an energy provider property without lawful
 authority and without the consent of the energy provider that owns, leases, or
 operates the property is guilty of a Class H felony.
