## 2015 ASSEMBLY BILL 767

January 22, 2016 – Introduced by Representatives RODRIGUEZ, BILLINGS, R. BROOKS, CONSIDINE, GANNON, KREMER, KULP, MACCO, PETERSEN, SCHRAA, TITTL, VORPAGEL, ZEPNICK and A. OTT, cosponsored by Senators ROTH, GUDEx, MARKLEIN, PETROWSKI, SHILLING and OLSEN. Referred to Committee on Criminal Justice and Public Safety.

1     **AN ACT to amend** 813.12 (5m), 813.122 (5g), 813.123 (5g) and 813.125 (5m); and  
2             **to create** 813.12 (4g), 813.122 (5c), 813.123 (5c) and 813.125 (4g) of the  
3             statutes; **relating to:** injunctions against harrassment and abuse.

---

***Analysis by the Legislative Reference Bureau***

This bill allows a court that enjoins a person (respondent) from certain acts of harassment, domestic abuse, or other abuse to order a wireless telephone service provider (provider) to transfer, from the respondent to the person who requested the injunction (petitioner), all rights to, and responsibility for, the use of telephone numbers used by the petitioner or by his or her minor children.

The bill requires the provider to complete the transfer within 72 hours of receiving the order, unless the account has already been terminated, the transfer would make one or more devices inoperable or dysfunctional, or a transfer would cause geographic or other limitations on service to the petitioner. The bill grants immunity from civil liability to providers for their compliance with the court order.
