## 2017 SENATE BILL 165

- April 13, 2017 Introduced by Senators Marklein, Testin, Cowles, Bewley, CARPENTER, HANSEN, HARSDORF, OLSEN, RINGHAND, SHILLING, VUKMIR and ERPENBACH, cosponsored by Representatives E. BROOKS, QUINN, TRANEL, JAGLER, TITTL, EDMING, NOVAK, RIPP, BERNIER, RODRIGUEZ, MURSAU, KITCHENS, SNYDER, GENRICH, KULP, MEYERS, PETRYK, SPIROS, SUMMERFIELD, TUSLER, VANDERMEER, ZIMMERMAN, NERISON, SWEARINGEN, KRUG, TAUCHEN and BILLINGS. Referred to Committee on Revenue, Financial Institutions and Rural Issues.
- 1 AN ACT *to create* 20.435 (1) (fi) and 146.616 of the statutes; **relating to:** grants 2 for education and training of allied health professionals and making an 3 appropriation.

## Analysis by the Legislative Reference Bureau

This bill requires the Department of Health Services to distribute grants to hospitals, health systems, and educational entities that form health care education and training consortia for allied health professionals. The bill limits the amount the department may distribute each fiscal year per consortium to \$125,000, which may used for curriculum and faculty development, tuition reimbursement, or clinical site or simulation expenses. The bill also requires a grant recipient to match through its own funding sources the amount of the grant awarded by the department.

13	In this section:
14	(a) "Allied health professional" means any individual who is a health care
15	provider other than a physician, registered nurse, dentist, pharmacist, chiropractor,
16	or podiatrist and who provides diagnostic, technical, therapeutic, or direct patient
17	care and support services to the patient.
18	(b) "Clinic" has the meaning given in s. 146.903 (1) (b).
19	(c) "Hospital" has the meaning given in s. 50.33 (2).
20	(d) "Rural clinic" means a clinic that is located in a city, town, or village in this
21	state that has a population of less than 20,000.
22	(e) "Rural hospital" means a hospital that is located in a city, town, or village
23	in this state that has a population of less than 20,000.

1	(2) From the appropriation under s. $20.435$ (1) (fi), subject to subs. (3) to (5),
2	the department shall distribute grants to hospitals, health systems, and educational
3	entities that form health care education and training consortia for allied health
4	professionals. The department shall distribute the grants under this section to
5	hospitals, health systems, and educational entities that apply, in the form and
6	manner determined by the department, to receive a grant and that satisfy the
7	requirements established by the department under sub. (4).
8	(3) (a) The department may distribute up to \$125,000 per fiscal year per
9	consortium to be used for any of the following:
10	1. Curriculum and faculty development.
11	2. Tuition reimbursement.
12	3. Clinical site or simulation expenses.
13	(b) A recipient awarded a grant under this section shall match through its own
14	funding sources the amount of the grant distributed by the department for the
15	purposes of operating an allied health professional training consortium.
16	(4) The department shall determine the requirements for the formation of
17	health care education and training consortia for allied health professionals.
18	(5) In distributing grants under this section, the department shall give
19	preference to rural hospitals, health systems with a rural hospital or rural clinic, and
20	rural educational entities.
21	SECTION 4. Effective date.
22	(1) This act takes effect on the day after publication, or on the 2nd day after
23	publication of the 2017 biennial budget act, whichever is later.
