## **2019 SENATE BILL 411**

September 16, 2019 – Introduced by Senators BEWLEY and PETROWSKI, cosponsored by Representatives MILROY and SKOWRONSKI. Referred to Committee on Transportation, Veterans and Military Affairs.

## Analysis by the Legislative Reference Bureau

This bill directs the Department of Transportation to designate and, upon receipt of sufficient contributions from interested parties, mark the bridge on USH 2 across the St. Louis River between the city of Superior in Douglas County and the city of Duluth in the state of Minnesota as the "Richard I. Bong Memorial Bridge."

**SECTION 4.** 84.1036 (2) of the statutes is amended to read:

7 84.1036 (2) Upon receipt of sufficient contributions from interested parties, 8 including any county, city, village, or town, to cover the costs of erecting and 9 maintaining markers along the route specified in sub. (1) (a) to clearly identify to motorists the designation of the route as the "Major Richard I. Bong Memorial 10 11 Highway," the department shall erect and maintain the markers. Upon receipt of 12sufficient contributions from interested parties, including any county, city, village, 13or town, to cover the costs of erecting and maintaining markers at the bridge 14specified in sub. (1) (b) to clearly identify to motorists the designation of the bridge as the "Richard I. Bong Memorial Bridge," the department shall erect and maintain 1516 the markers. No state funds, other than from the receipt of contributions under this 17subsection, may be expended for the erection or maintenance of the markers. 18 (END)
