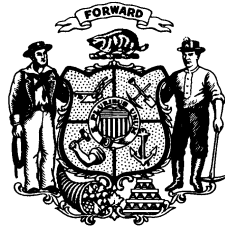

PREFACE

This **General Report** of the Joint Legislative Council to the 2001-02 Legislature is prepared pursuant to s. 13.81 (3) of the Wisconsin Statutes. It summarizes the work of the Joint Legislative Council from July 1, 2000 to June 30, 2002 and of those statutory and special study committees established by the Council to report to the 2001-02 Legislature.

The Joint Legislative Council continued two statutory committees and established 12 special committees to conduct various studies and to make reports to the 2001-02 Legislature. [See list on pages 1 and 2 of Part I.]

As of June 30, 2002, the following 16 reports containing the recommendations of study committees were submitted to the 2001-02 Legislature dealing with the substantive issues considered by these committees. WORK OF THE 2000-02 JOINT LEGISLATIVE COUNCIL

WORK OF THE 2000-02 JOINT LEGISLATIVE COUNCIL

The Joint Legislative Council held eight meetings between July 1, 2000 and June 30, 2002 (the period covered by this report) on the following dates:

The proposals introduced by the Joint Legislative Council and the Law Revision Committee are discussed in Part II of this report.

Council Study Committees

During the period covered by this report, the Council functioned with two statutory committees and nine special committees that were established to report to the 2001-02 Joint Legislative Council. [The Council voted to establish the Special Committee on Special Education, but did not appoint the membership of the committee.]

The statutory committees were:

Organization and Activities of the Joint Legislative Council

The Joint Legislative Council is a body composed of 22 Legislators, 11 from the Senate and 11 from the Assembly. Twelve of these members are *ex officio*--that is, they serve on the Council because of their positions as legislative leaders--and are the following: the Speaker of the Assembly, the President of the Senate, the Speaker Pro Tempore of the Assembly, President Pro Tempore of the Senate, the Assembly and Senate Majority and Minority Leaders, the two Co-Chairs of the Joint Committee on Finance, and the ranking minority member of the Joint Committee on Finance from each house. The other 10 members are appointed as are members of standing committees; five are appointed by the Chair of the Senate Committee on Organization and five by the Speaker of the Assembly. [s. 13.81 (1), Stats.]

The Joint Legislative Council works through a committee system during the recess periods of the Legislature. The Council determines which studies will be conducted and assigns these studies to particular committees created by the Council for these committees' review, study, and recommendations. These studies generally are of four types:

1. Intensive examination of problems that are expected to confront a succeeding Legislature.
2. Review of controversial subjects that were unresolved by the previous Legislature.
3. Major codifications and revisions of portions of the law.
4. Methods of improving the operation and effectiveness of state agencies.

There are two continuing Council committees currently required by statute [s. 13.83, Stats.]: the State-Tribal Relations Committee and the Law Revision Committee.

Under s. 13.82 (1), Stats., all studies or investigations that are proposed by the Legislature to be conducted are referred to the Council. Individual Legislators and others often request, by letter, that a particular study be undertaken. Also, the Council is given specific statutory authority to initiate such studies as it feels will be of value to the citizens of the state. The Council determines which of the studies will be conducted, based on its judgment of which studies should have priority within the limits of the Council appropriation and staff resources.

The end result of this study activity is the submission by the committees of reports and, in almost all cases, implementing legislation to the Joint Legislative Council. The Council reviews the legislative proposals and introduces in the Legislature those it approves by a majority of the membership of the Council (12 votes).

Operation of Council Staff

The Joint Legislative Council and the Council's study committees are staffed by a central nonpartisan legislative service agency. The Legislative Council staff serves in the unclassified service. As of June 30, 2002, the Council staff included, in addition to the Director, 16 attorneys, three analysts, and nine fiscal and support staff.

The basic duties of the staff include:

1. To provide legal, scientific and policy research, and administrative-secretarial services for the Council and its committees.
2. To provide legal, scientific and policy research, and analysis services for the Legislature's substantive standing committees and joint committees.
3. To provide legal, scientific, and policy research services for individual Legislators.
4. To serve as the Administrative Rules Clearinghouse for review of all proposed administrative rules.
5. To provide information to the public.

Each of these activities is discussed briefly below.

Services for the Council and its Committees. The Council staff provides services for the Joint Legislative Council and its study committees.

Services for Legislative Committees. The Council staff provides nonpartisan legal counsel and scientific and policy research for standing committees and their subcommittees, select or special committees of the Legislature and a number of joint statutory committees. The Council staff serves as the secretariat for the Joint Committee on Legislative Organization and for the Joint Committee on Employment Relations. Council staff also provides services to ad hoc or informal legislative study committees.

Services for Individual Legislators. Upon request, the Council staff provides legal analysis and other research to individual legislators.

Administrative Rules Clearinghouse. Prior to any public hearing on proposed rules, or prior to notification of legislative standing committees if no hearing is required, the agency proposing the rules must submit the proposed rules to the Council staff for review. The Council staff is required to review the proposed rules for various technical requirements, such as legal authority for promulgation of the rules and the form and clarity of the rules. The Council staff may issue advisory recommendations concerning the proposed rules. The Council staff also works with and assists the appropriate standing committees throughout the rule-making process. For additional information, see the Clearinghouse's *Annual Report* to the Legislature. [See s. 227.15, Stats.]

Services to the Public. The Council staff is available to answer questions from members of the general public and from research agencies and legislators of other states. Information about the Council staff, as well as publications prepared by the staff, are available at <http://www.legis.state.wi.us/lc>.

Seminars. Dr. Sung Won Sohn, Executive Vice President and Chief Economic Officer of Wells Fargo Bank, spoke to the members of the Joint Legislative Council and other interested persons on October 31, 2001, in the State Capitol. He presented a strategic outlook for the Wisconsin economy and a dialog of the role of government in addressing these future issues. Dr. Harold Hodgkinson, Director of the Center for Demographic Policy, Institute for Education Leadership in Washington, D.C., spoke to the members of the Joint Legislative Council and other interested persons on February 13, 2002, in the State Capitol. He gave a very informative presentation on how demographics affect Wisconsin issues both in the present and future. He shared with the Council several tables and graphs which illustrated how Wisconsin ranks among the other states and explained how many factors affected those rankings (i.e., population, climate, income, etc.). Dr. Hodgkinson presented a similar speech later that day to the Madison Rotary Club. ARTS FUNDING

Summary of Committee Activity

The Joint Legislative Council established the Special Committee by a May 18, 2000 mail ballot and appointed the co-chairs and members by June 13 and August 14, 2000 mail ballots, respectively. The Special Committee was directed to study state arts funding and to solicit information and develop summaries of funding recommendations made by the arts communities and local governments.

The membership of the Special Committee consisted of 1 Senator, 3 Representatives, and 10 Public Members. A list of the committee membership can be found in the *Appendix* to this report.

Actions of the Joint Legislative Council

At its March 14, 2001 meeting, the Joint Legislative Council voted to introduce the two bill drafts recommended by the Special Committee:

- 2001 Senate Bill 164, relating to creating an artistic endowment foundation and fund, creating an income tax credit for contributions to the fund, creating a sales tax exemption for sales of tickets and admissions by nonprofit organizations, granting rule-making authority, and making appropriations.
- 2001 Senate Bill 165, relating to special distinguishing registration plates in support of the arts.

Actions of the Legislature

2001 Senate Bills 164 and 165 failed to be enacted into law during the 2001-02 Legislative Session. Provisions of Senate Bill 164 (artistic endowment foundation) were included in 2001 Senate Bill 55 (which became 2001 Wisconsin Act 16, the 2001-03 Biennial Budget Act). Governor McCallum vetoed the provisions relating to tax credits for contributions to the foundation, but retained language creating the foundation.

CONDOMINIUM LAW REVIEW

Summary of Committee Activity

The Joint Legislative Council established the Special Committee by a May 18, 2000 mail ballot and appointed the co-chairs and members by June 13 and August 14, 2000 mail ballots, respectively. The Special Committee was directed to study ways to protect the investments of current and future condominium unit owners and ways to facilitate the appropriate development of the condominium form of property ownership. The committee was directed to review all aspects of condominium law, including: the development and establishment of condominiums; the governance of condominium associations, including the establishment of an annual budget and maintenance of reserve funds; the ownership and sale of condominiums; and rental of condominiums. The committee was also directed to study ways to address concerns of local units of government in which condominiums are located.

The membership of the Special Committee consisted of 2 Senators, 4 Representatives, and 10 Public Members. A list of the committee membership can be found in the *Appendix* to this report.

- 2001 Assembly Bill 781 and 2001 Senate Bill 412, relating to revisions and additions to condominium law.

Actions of the Legislature

2001 Assembly Bill 781 and 2001 Senate Bill 412 failed to be enacted into law during the 2001-02 Legislative Session.

DENTAL CARE ACCESS

Summary of Committee Activity

The Joint Legislative Council established the Special Committee by a May 18, 2000 mail ballot and appointed the co-chairs and members by June 13 and August 14, 2000 mail ballots, respectively. The Special Committee was directed to examine ways to increase access to dental care by underserved populations in Wisconsin, particularly those who are enrolled in Medical Assistance (MA) and BadgerCare. The committee was directed to examine the sufficiency of the number of dental care professionals in Wisconsin and the location of their practices; the number of MA, BadgerCare and other low-income persons they serve; ways to increase dental services being provided to underserved populations in Wisconsin; and reimbursement and administrative issues surrounding the provision of dental services under the MA and BadgerCare programs.

The membership of the Special Committee consisted of 3 Senators, 5 Representatives, and 13 Public Members. A list of the committee membership can be found in the *Appendix* to this report.

Actions of the Joint Legislative Council

At its March 14, 2001 meeting, the Joint Legislative Council voted to introduce the two bill drafts recommended by the Special Committee and to introduce them as companion bills in both houses of the Legislature. The first set of companion bills incorporated the Special Committee's fiscal recommendations, while the second set of companion bills incorporated the Special Committee's nonfiscal recommendations. The two sets of companion bills introduced by the Joint Legislative Council were as follows:

- 2001 Senate Bill 166 and 2001 Assembly Bill 366, relating to the state contract for dental education; authorizing licensed dental health professional positions in the Department of Health and Family Services (DHFS); funding for dental services at community health centers; grants for community water fluoridation; increasing the MA reimbursement rates for dental services; making topical fluoride varnish a covered service under the early and periodic screening, diagnosis, and treatment program; creating a fluoride varnish education program; reimbursement for dental hygienist services under MA; MA reimbursement for dental cleanings; requiring the exercise of rule-making authority; and making appropriations.

- 2001 Senate Bill 167 and 2001 Assembly Bill 367, relating to regional dental testing service examinations; dentist licenses for individuals licensed in another jurisdiction; the scope of practice of dental hygienists; delegation of dentistry practices to dental hygienists and unlicensed individuals; providing loan assistance to dentists and dental hygienists who practice in underserved areas; requiring the technical college system board to report on community dental health education; requiring the dentistry examining board and the DHFS to prepare a joint report on the ability of the dental work force to meet dental needs; requiring the DHFS to prepare a plan for a comprehensive oral health data collection system; requiring the DHFS to report on prior authorization for dental services under MA; and requiring the DHFS and the Department of Regulation and Licensing to prepare joint reports on improved access to dental services and dental hygiene services.

Actions of the Legislature

2001 Senate Bill 166 and 2001 Assembly Bill 366, as well as 2001 Senate Bill 167 and 2001 Assembly Bill 367, failed to be enacted into law during the 2001-02 Legislative Session.

However, several provisions relating to dental access were included in 2001 Wisconsin Act 16 (the 2001-03 Biennial Budget Act). Those provisions of Act 16 that relate to dental access included the following: (1) increasing the number of Wisconsin residents who qualify for state tuition assistance at the Marquette School of Dentistry from 100 to 160 (i.e., from 25 to 40 per class); (2) including dentists and dental hygienists in two loan programs operated by the Department of Commerce--the Physician Loan Assistance Program (renamed the Physician and Dentist Loan Assistance Program) and the Health Care Provider Loan Assistance Program; (3) providing state general purpose revenue funding for two rural health dental clinics, one in Ladysmith and one in Menomonie; and (4) requiring the Dentistry Examining Board to grant a dental license to a person who is licensed in good standing in another jurisdiction and who has been offered employment as a full-time faculty member at the Marquette School of Dentistry. Such a license may be used to practice dentistry only within educational facilities and only for the purpose of carrying out the licensee's teaching duties.

DEVELOPMENTAL DISABILITIES

Summary of Committee Activity

The Joint Legislative Council established the Special Committee and co-chairs by a June 13, 2000 mail ballot and appointed the members by an August 14, 2000 mail ballot. The Special Committee was directed to review funding issues, staffing concerns, and ways to streamline the bureaucracy that provides services to people with developmental disabilities. The study focused on providing opportunities for persons with developmental disabilities to live independently. The committee reviewed the implications of the Olmstead decision.

The membership of the Special Committee consisted of 2 Senators, 2 Representatives, and 9 Public Members. A list of the committee membership can be found in the *Appendix* to this report.

Actions of the Joint Legislative Council

At its May 15, 2001 meeting, the Joint Legislative Council voted to introduce the two bill drafts recommended by the Special Committee and to introduce them as companion bills in both houses of the Legislature. The first set of companion bills incorporated the Special Committee's recommendation to create a task force to develop a plan for the state centers for the developmentally disabled; the second set of companion bills incorporated the Special Committee's nonfiscal recommendations; and the third set of companion bills incorporated the Special Committee's fiscal recommendations. The three sets of companion bills introduced by the Joint Legislative Council were as follows:

- 2001 Senate Bill 231 and 2001 Assembly Bill 473, relating to requiring the creation of a task force to develop a plan for the state centers for the developmentally disabled.
- 2001 Senate Bill 289 and 2001 Assembly Bill 590, relating to adding legislative members to the Council on Developmental Disabilities; requiring the Council on Developmental Disabilities to report annually to the Legislature; expanding eligibility, requiring submission of waiver requests by a specified date, and providing transitional services under a pilot program for long-term care of children with disabilities; requiring the DHFS to develop a plan to administer and fund services for persons with developmental disabilities; and requiring the exercise of rule-making authority.

- 2001 Senate Bill 346 and 2001 Assembly Bill 671, relating to increasing funding for services under the family support program and the respite care program; increasing the daily reimbursement rate for the community integration program for persons with mental retardation; providing funding for MA home and community-based services for persons with developmental disabilities who are on waiting lists for services; requiring the DHFS to establish criteria for distribution of this funding and to develop a plan to eliminate waiting lists for services for persons with developmental disabilities by the end of state fiscal year 2004-05; requiring the Council on Developmental Disabilities to evaluate, and report to the Legislature, the number of persons with developmental disabilities on waiting lists for services at the end of each calendar year; requiring the exercise of rule-making authority; and making appropriations.

Actions of the Legislature

2001 Senate Bill 231 and 2001 Assembly Bill 473, 2001 Senate Bill 289 and 2001 Assembly Bill 590, and 2001 Senate Bill 346 and 2001 Assembly Bill 671, failed to be enacted into law during the 2001-02 Legislative Session.

However, several provisions relating to services for persons with developmental disabilities were included in 2001 Wisconsin Act 16 (the 2001-03 Biennial Budget Act). Those provisions of Act 16 that related to developmental disabilities services included the following: (1) incorporating the brain injury waiver (BIW) program into the community integration IB program (CIP IB) program to provide counties the authority to create additional slots and fund additional expenditures above the state-funded BIW levels and capture additional federal matching funds by providing the nonfederal share of the BIW costs; (2) requiring DHFS to promulgate rules that provide that the written plan of care for MA recipients receiving personal care services must designate an interval for visits to the recipient's home by a registered nurse as part of the review of the plan, based on the individual recipient's needs, with at least one visit in every 12-month period; (3) requiring DHFS to seek a waiver of federal MA statutes and regulations necessary to provide to disabled individuals under 24 years of age, under one program with uniform administration and service delivery, the services available under several MA community-based waiver programs, the family support program and the birth-to-three program; (4) increasing funding for the family support program by \$250,000 in 2001-02 and by \$750,000 in 2002-03; (5) indicating that grants provided in the life-span respite care project are to be provided in subsequent biennia; (6) creating 310 additional slots under the CIP IB program in 2001-02; and (7) increasing the daily rate for the CIP IB program from \$48.33 per day to \$49.67 per day, for both current and new slots.

GUARDIANS AD LITEM IN ACTIONS AFFECTING THE FAMILY

Summary of Committee Activity

The Joint Legislative Council established the Special Committee by a May 18, 2000 mail ballot and appointed the co-chairs and members by June 13 and August 14, 2000 mail ballots, respectively. The Special Committee was directed to study the guardian ad litem system as it applies to actions affecting the family, including an examination of the appointment, role, supervision, training and compensation of guardians ad litem. The review of the appointment of guardians ad litem was to include the necessity of appointment in contested custody or placement cases and whether professionals with specialized expertise in the emotional and developmental phases and needs of children should be appointed to act as guardians ad litem. The committee was asked to prepare a report of any recommended legislation and petition the Wisconsin Supreme Court to consider rules for the reform of the guardian ad litem system in actions affecting the family based on the committee's recommendations that were more appropriate for supreme court rules.

Actions of the Joint Legislative Council

At its March 14, 2001 meeting, the Joint Legislative Council voted to introduce the bill draft recommended by the Special Committee:

- 2001 Senate Bill 126, relating to guardians ad litem, parent education and parenting plans in actions affecting the family.

The Joint Legislative Council also voted to approve and send a petition to the Wisconsin Supreme Court to amend rules relating to eligibility for appointment as a guardian ad litem of a minor.

Actions of the Legislature

2001 Senate Bill 126 failed to be enacted into law during the 2001-02 Legislative Session.

The Wisconsin Supreme Court adopted the recommendations in the petition filed by the Joint Legislative Council on December 14, 2001.

LABOR SHORTAGE

Summary of Committee Activity

The Joint Legislative Council established the Special Committee by a May 18, 2000 mail ballot. The co-chairs were appointed by a June 13 mail ballot and the members by an October 12, 2000 mail ballot. The Special Committee was directed to: (1) study the labor shortage in Wisconsin, including strategies to eliminate shortages in critical industries and occupations; (2) review the so-called "brain drain" problem and identify ways that Wisconsin can retain college and university graduates as well as recruit workers from other states; and (3) examine the skilled building trades for barriers to minorities entering those trades, the methods by which schools train students for those trades and ways to expand trades-related apprenticeship training opportunities.

The membership of the Special Committee consisted of 3 Senators, 3 Representatives, and 25 Public Members. A list of the committee membership can be found in the *Appendix* to this report.

Actions of the Joint Legislative Council

At its May 15, 2001 meeting, the Joint Legislative Council voted to introduce the two drafts recommended by the Special Committee and to introduce them as companion legislation in both houses of the Legislature. The first set of companion bills incorporated the bulk of the Special Committee's recommendations with respect to the labor shortage, while the second set were resolutions to Congress. The two sets of companion legislation introduced by the Joint Legislative Council were as follows:

- 2001 Senate Bill 249 and Assembly Bill 516, relating to special labor-related reports; training, education, and development zone tax credits; training and education programs; providing an exemption from emergency rule procedures; granting rule-making authority; and making appropriations.
- 2001 Senate Joint Resolution 41 and Assembly Joint Resolution 57, relating to memorializing Congress to study and modify the Social Security earnings limit.

Actions of the Legislature

2001 Senate Bill 249 and Assembly Bill 516 and 2001 Senate Joint Resolution 41 and Assembly Joint Resolution 57 failed to be enacted into law or adopted during the 2001-02 Legislative Session.

However, several provisions originally offered for introduction by the Special Committee were included, in substantial part, in 2001 Wisconsin Act 16 (the 2001-03 Biennial Budget Act). Those provisions related to the creation of the nursing student loan forgiveness program, and the creation of a journey worker credential pilot program in up to three trades, crafts, or businesses.

LAW REVISION

Summary of Committee Activity

The Law Revision Committee was first created by the Legislative Council at its May 30, 1980 meeting, as a statutory committee of the Council, pursuant to s. 13.83 (1), Stats., as created by Ch. 204, Laws of 1979. The membership of the committee is to be appointed in "each biennium." Members were most recently appointed by a May 16, 2001 mail ballot. The membership of the committee consists of 4 Senators and 4 Representatives. A list of the committee membership can be found in the *Appendix* to this report.

The committee is directed to:

1. Review remedial legislation based on nonsubstantive changes recommended by agencies;
2. Review court decisions and opinions of the Attorney General which state that a statute is unconstitutional, ambiguous, or otherwise in need of revision; and
3. Review correction bills and minor substantive revision bills prepared by the Revisor of Statutes.

The committee is directed to introduce the bills prepared on these subjects directly, not through the Council, into the Legislature.

The committee may recommend to the Council major law revision projects to be undertaken by the Law Revision Committee, a special or permanent Council committee, legislative service agency, or committee of the Legislature.

The committee is also directed to cooperate with the Revisor of Statutes in a 10-year systematic examination of the statutes to identify provisions needing revision and to perform functions relating to interstate compacts and agreements.

The committee's activities for each of these responsibilities are discussed below under the appropriate heading.

Court Cases and Attorney General Opinions

As of the date of this report, the Revisor of Statutes has submitted to the Law Revision Committee 119 state and federal court decisions and Attorney General opinions, covering the period from August 1996 to July 2002, holding statutes unconstitutional, ambiguous, or otherwise in need of revision.

The Law Revision Committee has not reviewed the 30 items covering the period from August 1996 to November 1998 contained in the 1998 case and opinion review, Discussion Paper 01-1, *Law Revision Committee: Case and Opinion Review*, dated November 27, 2001.

In a letter dated July 24, 2000, the Revisor of Statutes submitted 50 state and federal court decisions and Attorney General opinions items holding statutes unconstitutional, ambiguous, or otherwise in need of revision to the Law Revision Committee. These items cover the period from December 1998 to July 2000, and will be summarized in a 2000 report to the Law Revision Committee.

In a letter dated July 29, 2002, the Revisor of Statutes submitted 39 state and federal court decisions and Attorney General opinions items holding statutes unconstitutional, ambiguous, or otherwise in need of revision to the Law Revision Committee. These items cover the period from July 2000 to July 2002, and will be summarized in the 2002 report to the Law Revision Committee.

There were no case and opinion bills introduced in the 2001-03 Legislative Session.

The four sets of companion bills introduced by the Joint Legislative Council were as follows:

- Assembly Bill 667 and Senate Bill 335, relating to the intoxicated operation of an all-terrain vehicle, motorboat or snowmobile.
- Assembly Bill 668 and Senate Bill 336, relating to safety training for all-terrain vehicle and motorboat operation.
- Assembly Bill 669 and Senate Bill 337, relating to requiring that personal flotation devices be worn by certain underaged persons in certain boats.
- Assembly Bill 670 and Senate Bill 338, relating to intoxicated operation of a motor vehicle and providing a penalty.

None of the bills introduced by the Joint Legislative Council on the recommendation of the Special Committee were enacted into law during the 2001-02 Legislative Session.

STATE-TRIBAL RELATIONS

Summary of Committee Activity

The Special Committee on State-Tribal Relations is a permanent committee of the Joint Legislative Council established under s. 13.83 (3), Stats. The committee is directed by statute to:

. . . study issues related to American Indians and the American Indian tribes and bands in this state and develop specific recommendations and legislative proposals relating to these issues.

The membership of the committee, appointed by the Joint Legislative Council, consists of not fewer than 6 nor more than 12 legislator members of the Senate and Assembly, including at least one member of the majority party and at least one member of the minority party from each house, and not fewer than 6 nor more than 11 members selected from names submitted by the federally recognized American Indian tribes and bands in this state or the Great Lakes Inter-Tribal Council (GLITC). The committee is assisted by a Technical Advisory Committee (TAC) composed of a representative of each of the following state departments: Health and Family Services; Workforce Development; Justice; Natural Resources; Public Instruction; Revenue; and Transportation. A list of the committee membership and the TAC membership can be found in the *Appendix* to this report.

The Special Committee held nine meetings during the period covered by this report on the following dates at the locations indicated:

September 10, 2001 (Red Cliff Indian Reservation)

November 13, 2001 (Stockbridge-Munsee Indian Reservation)

Actions of the Joint Legislative Council

At its March 14, 2001 meeting, the Joint Legislative Council voted to introduce one bill recommended by the Special Committee:

- 2001 Assembly Bill 223, relating to tribal administration of rehabilitation reviews for persons who otherwise may not operate, be employed at, contract with, or reside at an entity that provides care for children or adults and granting rule-making authority.

At its January 30, 2002 meeting, the Joint Legislative Council voted to introduce five pieces of legislation recommended by the Special Committee, consisting of two joint resolutions and two bills on the subject of state-tribal relations and one bill on the subject of the labeling of wild rice sold in Wisconsin. The pieces of legislative legislation introduced by the Joint Legislative Council were as follows:

- 2001 Assembly Joint Resolution 90, relating to a policy of executive branch consultation with tribal governments.
- 2001 Assembly Joint Resolution 92, relating to state recognition of the sovereign status of federally recognized American Indian tribes and bands.
- 2001 Assembly Bill 771, relating to creation of the Wisconsin tribal-state council and making an appropriation.
- 2001 Assembly Bill 772, relating to preparation of tribal impact statements for bills that would have an impact on tribal governments or American Indians.
- 2001 Assembly Bill 773, relating to representations made regarding wild rice sold or offered for sale in this state, granting rule-making authority, and providing a penalty.

Actions of the Legislature

None of the bills introduced by the Joint Legislative Council on the recommendation of the Special Committee was enacted into law during the 2001-02 Legislative Session, and neither of the joint resolutions was adopted.

The four proposals relating to communications between state government and tribal governments (2001 Assembly Joint Resolutions 90 and 91 and 2001 Assembly Bills 771 and 772) were introduced very late in the 2001-02 Legislative Session. They were introduced on February 5, 2002; the regular session was adjourned on March 26, 2002. The Assembly Committee on Government Operations held a public hearing on all four proposals on February 27, 2002. No further action was taken after that date.

Senator Gary George, Vice Chair of the Special Committee, introduced companions to these proposals, that is, Senate joint resolutions and bills that were identical to the Assembly joint resolutions and bills that the Joint Legislative Council introduced at the Special Committee's recommendation. Specifically, these were 2001 Senate Joint Resolution 60 (a companion to Assembly Joint Resolution 90), 2001 Senate Joint Resolution 61 (a companion to Assembly Joint Resolution 91), 2001 Senate Bill 466 (a companion to Assembly Bill 771), and 2001 Senate Bill 467 (a companion to Assembly Bill 772). Like the Assembly proposals, these proposals were introduced very late in the legislative session. They did not receive public hearings or other action.

During a special session called to review the state budget, the Senate incorporated the provision of Assembly Bill 771, creating a Wisconsin tribal-state council, into its version of January 2002 Special Session Assembly Bill 1, the 2001-03 Budget Reform Bill. The Assembly did not concur in this action. The Conference Committee later removed the provision from the bill.

2001 Assembly Bill 773, regarding the labeling of wild rice, was also introduced on February 5, 2002, less than two months before the end of the regular legislative session. It was passed by the Assembly on a voice vote but failed to receive a public hearing in the Senate committee, and so was not concurred in by the Senate and ultimately failed to pass.

USE OF PRESCRIPTION DRUGS FOR CHILDREN

Summary of Committee Activity

The Joint Legislative Council established the Special Committee and co-chairs by a June 13, 2000 mail ballot and appointed the members by an October 12, 2000 mail ballot. The Special Committee was directed to study issues surrounding the use of prescription drugs to modify children's behavior, including the safety, efficacy, and appropriateness of the use of those drugs and determine whether such drugs are safely and appropriately prescribed and labeled.

The membership of the Special Committee consisted of 1 Senator, 5 Representatives, and 14 Public Members. A list of the committee membership can be found in the *Appendix* to this report.

Actions of the Joint Legislative Council

At its meeting on June 27, 2001, the Joint Legislative Council voted to introduce one bill recommended by the Special Committee:

- 2001 Assembly Bill 672, relating to requiring physicians to provide certain information when issuing prescription orders to treat children with attention deficit hyperactivity disorder.

Actions of the Legislature

2001 Assembly Bill 672 failed to be enacted during the 2001-02 Legislative Session.
