I would like to thank Chairman Feyen and members of the committee for accepting my testimony on Senate Bill 369 (SB 369).

When the Verso Corporation closed its paper mill in Wisconsin Rapids last year, it affected the lives of 905 employees. Due to the COVID-19 pandemic, the mill was shut down and Wisconsin Rapids and Wood County lost a major employer.

As devastating as this was for that community, the shuttering of that mill had repercussions that extended farther in the state. In addition to high quality coated paper, the mill also produced paper pulp. About one-quarter of all pulpwood in the state went to the Verso mill in Wisconsin Rapids. Without their consumption, scores of small timber cutters had no buyer for the softwood they harvested. That lack of wood cutting also affects many land owners who have property in the Managed Forest Land (MFL) program. Many of those land owners rely on the timber companies to help manage their forests.

Verso has put the mill up for sale. The Great Lakes Timber Professionals Association has been working with the UW to form a cooperative which could purchase the mill, make it operational again, and restore some jobs. This cooperative, called the Consolidated Cooperative, needs additional capital aside from what they have secured, to purchase and operate the mill.

What we are proposing with this bill is to allocate some of the federal pandemic stimulus funds as a loan to help the cooperative purchase the mill and get it back up and running. This would not be a handout. This would be a loan. And it would require the cooperative to obtain significant funds from other sources as well.

This is a chance to help a community, a region and an industry that was devastated by the pandemic. Thank you again for listening to my testimony and I hope that you will join me in supporting this bill.

Chairman Feyen and committee members:

Thank you for holding a hearing today on SB369. I call this the "Mill Bill". I write this testimony for the record but am certainly going to speak from the heart today. I grew up in Wisconsin Rapids, went to the public schools in Wisconsin Rapids, graduated (a while ago) from good ol' Lincoln High School, went to Mid-State Tech there and graduated as a proud MSTC Cougar. The whole while I have had dozens and dozens of family members working their tails off at Consolidated Papers, then Stora Enso, then New Page, then Verso. As much as I credit my success to my hard work, NONE of it would have been possible without each of my family at the mill and every other single employee, union and owner of that facility

This mill goes back many generations in Wisconsin Rapids. It is the backbone, the single biggest employer, the heartbeat of the community. When I got the call about a year ago that the mill would be "idled" I was heartbroken and so were thousands of people in the Wisconsin Rapids area and beyond. You see, this isn't just a Wisconsin Rapids mill, as you will hear from others today. The footprint of this closure reaches throughout the state of WI. When I entered office in 2011, I had been witnessing the downward slide of the facility and vowed I did NOT want to be the guy in this office when that place closed. Now I know that God had other plans and I was meant to be the guy to be in this office when this place closed.

We (Sen. Testin and I) jumped into action immediately upon hearing the news of a pending "idling" of the plant. First, we reached out to Verso to find out how the state could be of assistance to prevent this from happening. We learned that in their minds nothing would stop the closure; they stated that COVID had hit them hard. The impact in their estimation was harder than they anticipated. You see, this isn't the first hard time this mill had seen. It has survived the last pandemic, two World Wars,

the Great Depression and Great Recession and multiple ownership changes. It has seen it all, until now. Forced shutdowns in their consumer markets, threats from county government to close their doors, finally led Verso to say "That's enough, we're done."

Next, we called the Governor's office and hand delivered communication to the East Wing. I give credit to Governor Evers for taking our calls and being just as concerned as we are. He told us on multiple occasions, he would go along with whatever we came up with. That may have changed somewhat since then with the introduction of this bill and his return offer to tie the sale to the Medicaid expansion. Committee members I will tell you this, we ALL know this must happen. I pledge to you that I am willing to compromise on language of this bill as a standalone issue. We need to give Wisconsin Rapids its day in the Assembly, its day in the Senate and its day on the Governor's desk with a signature on the single largest issue facing it right now.

Sen. Testin and I started the Wisconsin Rapids Task Force prior to the closure of the mill, to gather stakeholders together for two purposes. We wanted to help find a buyer for the mill, and we wanted make sure needed community services were available to affected workers and families (at the height of a pandemic) to all affected, here and statewide. The stakeholders on our task force include state and federal government officials, me, Sen. Testin, Rep Shankland, Rep VanderMeer, as well as members of our Congressional delegation (Reps Kind and Rep Tiffany) and Senators Johnson and Baldwin. We worked with WEDC, the Governor's Office, DWD, DNR, the federal WIOA staff, and numerous other agencies to prepare for the worst. Locally we engaged our local chambers, United Way, the school districts, unions, employees and even Verso. All hands-on deck, NO POLITICS, we all played nice.

After a short time in conversations with various entities, a buyer emerged and an idea came forth to end the stalemate. We have an opportunity with the Consolidated Cooperative as a part of the Timber Professionals to come forward and be a local owner, something we haven't seen since the old Consolidated Papers in the 1990s. We worked through the investment bankers hired to conduct the outreach and sale to identify others as well. To this date no other buyer has specifically come forward to state an interest in making a purchase of the business, other than this buyer. This bill, geared towards that purchase, combines ALL the efforts of the task force with the ability to generate change with federal dollars. In the bill we specifically lay out parameters on how a potential transaction is to be laid out. The interested party would have to prove to have a sufficient amount of private funds before BCPL and WEDC can become involved. WEDC would then be allowed to craft a loan of up to \$50 million towards the purchase in conjunction with a pass-through loan from the BCPL. That combination along with private capital would make up the anticipated purchase amount of the facility and lead to production once again.

It is with great pride in my community that I humbly ask for your support and your help today in getting SB369 to be the lifeline that Wisconsin Rapids needs.

Testimony in Support of Senate Bill 369

Senate Committee on Economic and Workforce Development June 15, 2021

Mr. Chairman and committee members, thank you for holding a public hearing on Senate Bill (SB) 369 today. I appreciate having the opportunity to work with Representative Krug, Senator Testin, and Senator Felzkowski on this important legislation.

When the Verso paper mill closed last year the impacts were felt far outside of the Wisconsin Rapids area. Prior to its closure, this mill utilized approximately 25% of all the pulpwood harvested in Wisconsin. With this major customer gone, many timber professionals who sold to this mill have struggled to find new buyers for their product. I have heard from loggers in my district who lost 50% or more of their business when the Wisconsin Rapids mill closed. A large number of them have been unable to find new customers to replace the loss of Verso.

Beyond the impact on the timber industry, the closure of the Wisconsin Rapids mill has also negatively impacted the budgets of many northern counties. A number of counties across the Northwoods receive a significant amount of revenue from timber sales out of their county forests. For example, Rusk County which I represent is facing a loss of about \$267,000 annually. In Sawyer County, the loss is about \$204,000 annually. Other counties around northern Wisconsin are facing similar challenges.

Outside of the financial impacts, the harvest of timber is an important part of forest management. If the reduction in the harvest of pulpwood caused by the Wisconsin Rapids mill closure is not reversed the health of our state's forests could suffer resulting in an increased fire risk amongst other problems.

SB 369 would make a big difference in northern Wisconsin by providing the necessary funding to reopen the Wisconsin Rapids paper mill and return a very important customer for Wisconsin's timber industry. In addition, an amendment added in committee in the Assembly would also provide funding to reopen the paper mill in Park Falls. While this mill is smaller than the Wisconsin Rapids mill, adding another customer in Northern Wisconsin will be good for our state's timber industry and the local economy.

Mr. Chairman and members, I ask you to join me in supporting SB 369 and thank you again for the opportunity to testify before you today.

WHEREAS, the Wisconsin Rapids, WI mill utilizes over 25% of all pulpwood produced in the state of Wisconsin, and

WHEREAS, the forest products industry is the number 1 employer in Rusk County based on number of employees, and

WHEREAS, 58.7% of total pulpwood on active sales in Rusk County is hardwood pulp, of which over 90% would be consumed at the Wisconsin Rapids mill, and

WHEREAS, timber revenue from the Rusk County Forest reduces the County levy by 15-20% and the loss of this income will financially affect the 14,000+ citizens of Rusk County and the public services available to them, and

WHEREAS, a similar impact will be felt by nearly every County operating a County Forest for timber production.

Chair Feyen and Committee members,

The Great lakes Timber Professionals Association members and Board of Directors fully support Senate Bill 369 (SB 369).

Wisconsin's forest and timber products industry and ancillary businesses such as tourism depend on healthy forests. The most effective way to maintain healthy forests is with a healthy forest industry utilizing sustainably harvested wood from Wisconsin certified forests. Industry and healthy forest are equally dependent on one another. In fact, most, if not all wood consumers have agreed and stated publicly in years past, that to maintain forest health in Wisconsin and the Lake States Region, we cannot afford to lose another wood consuming mill. Since June 9th of last year, during the height of the pandemic, our region (Wisconsin, Minnesota, and Michigan) lost three wood consuming mills, two of which were in Wisconsin.

The lost wood consuming mills include two VERSO mills; one in Wisconsin Rapids, WI and Duluth, MN, and the Park Falls Pulp and Paper mill in Park Falls, WI. These closures have directly resulted in the loss of 1,300 jobs at the mills and negatively an additional 14,000 individuals and businesses who supply and service the mills. Those additionally impacted include loggers, truckers, equipment companies, parts distributors, repair facilities, fuel and oil distributors and stations, and landowners, including federal, state, county, and especially private lands.

Since the announced closure of the WI Rapids and Duluth MN Verso mills June 9th in 2020, stumpage revenues have dropped substantially for county, state, and private lands.

<u>County</u>: According to a report from DNR personal provided in February, county timber sale revenue decreased by 27% compared to 2019.

State: State timber sale revenue has decreased by 37% compared to 2019 revenue.

<u>Private:</u> Private land is harder to track, however, frequent calls received from landowners indicate they are struggling to find loggers willing to even harvest their wood at any price because of a lack of market.

The longer these mills are shuttered stumpage rates will continue to decline, making it more difficult of landowners to actively manage their land, decreasing the health of the forests and putting pressure on landowners to find other ways to keep land ownership affordable.

SB 369 provides a hand up, not a handout to Wisconsin's timber and forest product industry by supporting a multistakeholder cooperative approach. This cooperative ownership is much different than ownership under an individual or investment group because it involves several groups of owners including loggers, mill workers and additional industry allies who are putting a personal stake in the success of the facilities and the future of our industry. The loan provided in SB 369 will provide a longer-term benefit to a much broader group of citizens and taxpayers than a traditional economic development grant. GLTPA's also believes that cooperative ownership model of these facilities will provide greater long-term security for the industry and forest health.

In closing, as a representative of the state's second largest economic driver, the timber and forest products industry, we appreciate the leadership of the authors and the attention this issue has received from both the Legislature and the Administration. These loans will assist thousands of workers and the affiliated businesses in returning to work and supporting their families and communities. We need your assistance for the health of our industry, the health of our rural communities and the health of our forests and ask for your quick action on this solution, thank you.

Boisaco, Inc., a Community Owned Industry in Remote Quebec

Summary by Margaret M. Bau, Cooperative Development Specialist, USDA Rural Development June, 2012

Boisaco, Inc. is a fascinating example of a small logging town taking ownership of their economy. Sacre-Coeur (population 1881), situated on the remote north shore of the St. Lawrence River, was like many mill towns. After the third bankruptcy in 10 years, the town's sawmill lay idle for 2.5 years. When the bank tried to liquidate, the community collaborated with the provincial credit union and government to buy the mill for \$1.2 million. The community created Boisaco, Inc. ("bois" means "wood" in French) an ownership strategy composed of three entities (2 co-ops + 1 community investor group):

- 1) COFOR a worker co-op of 60 loggers harvesting wood in the forests. The co-op holds shares in Boisaco, Inc. and has seats on that corporation's board.
- 2) UNISACO a worker co-op of 142 millworkers in the processing plant. The co-op holds shares in Boisaco, Inc. and holds seats on that corporation's board
- 3) INVESTRA a community investor group comprised of 432 small shareholders in the region (local merchants, mayor, business community, and other workers). No family may own more than 5% of shares (to avoid a single family from holding a majority of shares).

The board composition consists of:

- 3 board members representing COFAR
- 3 board members representing UNISACO
- 3 board members representing INVESTRA
- 1 board member from Desjardins Capital de Risqué (the investment tool of Desjardins for venture capital) Desjardin is the powerhouse credit union system throughout Quebec.

A policy for distribution of surplus (profits) was created early on, and has served Boisaco and the entire community well:

18% to the workers in the logger and millworkers co-ops 27% to each shareholder (COFOR, UNISACO, INVESTRA) proportionately 55% to a development fund (after taxes)

That 55% development fund has allowed Boisaco to invest in or acquire five other regional companies (that buy Boisaco's products or by-products) and to modernize equipment. This foresight helped Boisaco diversify and ride out boom and bust cycles typical in the wood products industry. Those five companies include: granite cutting, a molded decorative panel manufacturer, a horse bedding manufacturer, forestry, and a pellet manufacturer.

Also key to Boisaco's success is the long history of transparency, participatory management (30% of workers have at some time served on a board), solidarity, and fairness. Workers are highly invested in avoiding waste and looking for cost savings. Before Boisaco was organized, the mill went through three ownerships and was closed for 30 months. People remember those times and realize how dependent the isolated community of 2,000 is upon this mill. There is also a strong desire to create good jobs to keep young people in the region.

With the crisis in the US housing market and the depressed prices for wood products, four years ago all involved in Boisaco reached an agreement to freeze wages and to implement 5-10% wage cuts when the

foot board measure reaches certain thresholds in the industry. This type of belt tightening has been done with an eye to avoid lay-offs (and what that would do to families and the potential permanent loss of those skilled workers).

State Senate Comments June 15, 2021

As Mayor of the City of Wisconsin Rapids, I am in support of the "mill bill" SB 369, which would assist a cooperative entity based in Northern Wisconsin in their objective of purchasing the Verso Paper Mill and putting it back into operation.

The closure of the Verso Paper Mill last July created an economic shock in Wisconsin Rapids and the surrounding region. The Verso Paper Mill was the largest employer within Wisconsin Rapids, employing over 900 people, most of whom lost their jobs after the closure. Area businesses that serve the mill will account for an additional 580 jobs lost due to the closure. The closure is estimated to impact nearly 2,000 jobs regionally, and over 2,600 jobs statewide. These job losses relate to lost earnings for Wisconsin's people and lost tax revenues for Wisconsin's cities.

The Verso Paper Mill also consumed one-quarter of the pulpwood cut annually in Wisconsin, advancing timber and transportation industries throughout the state, while keeping our forests sustainable and healthy.

The closure of our city's paper mill will have a profound effect on our community, our region and our state. And SB 369 poses an opportunity to bring back jobs, while ensuring our paper professionals' expertise stays local. It is an opportunity for our paper mill to again be locally owned and operated. Now is the time to act on SB 369 and spare us from seeing the full impact of this closure. I urge you to support this proposal and I thank you for your time.

COVID-19 Effects on the Operations of the Park Falls Mill

The current owner of the mill (which is now in Chapter 128 Receivership) bought the facility in November of 2019. The initial plan was to operate the pulp mill and sell market pulp, followed by selling paper off of one paper machine a few months later. In May of 2020, a key purchaser of a valuable byproduct that only this mill supplies, declared that if the byproduct was not available for purchase shortly, they would pull out of the contract and permanently end the relationship with the Park Falls Mill. This byproduct, the cooking "liquors" as a result of sulfite pulp making process, is an essential revenue stream for Park Falls, and without it would make the mill permanently unviable. The threat of this customer leaving the market spurred the owners to invest millions into the restart as soon as possible, with the mill restarting pulp operations in September of 2020.

There was a great sense of pride in reopening the facility after a year left idle. The resumption of pulp production occurred precisely at the time when the pulp and paper marketplace hit new lows due to the COVID-19 pandemic. Essentially, the mill had no place to go with their products after restart, with many customers canceling orders due to consumer demand.

The mill stockpiled its production from September to January, waiting for prices to recover, but also had to keep running at a high pulp mill output to satisfy their customer for the sulfite liquors. This COVID-19 related loss of sales left the owners with all the costs of running the mill, with virtually no revenue beyond that of the byproduct. The massive operating deficit was too much to recover from, even after the market started to recover in January of 2021. The mill ceased operations in March of 2021, and was put into receivership in May of 2021. If the market had not collapsed in the Fall of 2020 due to the massive pandemic related demand drop, the mill would almost certainly be operating.

The situation in the pulp and paper market has significantly rebounded. Park Falls would be making significant profits today if they were producing, providing a valuable outlet for timber in northern Wisconsin, employing hundreds of employees, and remaining a vital economic force for the entire northern Wisconsin supply chain.

I very much wish to go on record in support the adoption of SB 369.

My son and I own a small logging company in Menominee County in the western Upper Peninsula of Michigan. Occasionally we harvest timber in Wisconsin. Some of these sales have been on MFL lands. We do sell some round wood to various mills in Wisconsin.

Since the closure of the Verso mill in Wisconsin Rapids we have experienced a greatly reduced market for some species of wood as well a reduction in price from Verso's Michigan mills. Our operation is down about 35% this year. Some of this loss was due to the closure of Verso's Wisconsin Rapids mill.

This loss of market has had an impact on our ability to harvest timber in a sustainable manner. We have had to greatly reduce the amount of softwood we should be harvesting due to insect and disease issues. The soft market for pulpwood also impacts our ability to produce higher value products such as sawlogs.

The loss of the Wisconsin Verso mill has had a negative impact on a very large multistate wood basket as well as the forests in the Wisconsin Rapids area. Land owners, loggers, truckers, mills and their employees as well as supporting businesses in our communities have all felt the impact of this closure. It is imperative that this mill be re-opened. I feel this is possible by changing the mix of products that can produced by this mill.

The Wisconsin County Forests Association (WCFA) is writing in support of SB 369, also known as the "Mill Bill", and request to be registered as such in order that the Verso mill in Wisconsin Rapids might be purchased and put back into operation as soon as is feasible by a cooperative entity based in Northern Wisconsin. This will help ensure jobs return to the community and greater Wisconsin, and that our forests will regain an important buyer for pulpwood harvested in the State.

WCFA represents the 30 counties in Wisconsin with County Forest lands established under state statutes §28.10 and 28.11. Collectively, these 30 counties manage over 2.4 million acres of forests, the largest public ownership in our State. These counties are a major contributor to public land management and rural economic development, and are also highly valued because they provide a reliable source of raw materials for the forest products industry, as well as a tremendous amount of recreation opportunities.

Sustainable forests, outdoor recreation and public land management are vitally important to our State's economic health. As you know, forest products are the 2nd largest industry in Wisconsin, supporting more than 64,000 jobs and contributing over \$24 billion annually to the State's economy. The two Verso mills which were idled in June 2020 consumed roughly 25% of the total raw material harvested in Wisconsin, including the majority of low-grade hardwood pulp. Losing this, or any, large market puts sustainable forest management, including the viability of our healthy forests, in jeopardy. A summary of direct financial impact to the County Forests can be found on page 3.

Active sustainable forest management, including timber harvests, provide healthy forest conditions, robust wildlife habitat, clean water resources and offer numerous outdoor recreation amenities and services afforded primarily from timber sale revenues. In addition to economic setbacks, counties, and the citizens of Wisconsin, will likely see

Other county departments and services, and possibly tax levies, could be significantly impacted if revenues of harvested timber, due to lost markets, fall considerably.

RE: Financial impact to County Forests due to Verso shutdown

The Wisconsin Rapids Verso mill idled in summer 2020 consumed roughly 25% of the total raw material harvested in Wisconsin, and nearly 20% of timber harvested off of County Forest lands, including the majority of low-grade hardwood pulp. Losing this market puts sustainable forest management, including the viability of our healthy forests, in jeopardy.

On average, the County Forests return roughly \$40 million annually back to the counties and towns. Table 1 (right) details the direct financial impacts to the County Forests who shipped timber to Verso, over \$4 million annually.

However, the economic and environmental impacts go much further than those directly tied to the idling of the Verso mill. The closure also resulted in a massive shift in wood market dynamics, creating a supply and demand imbalance, with a large excess in supply with no market. In turn, this negatively affects sale rates and prices across the board for all counties.

For example, the direct financial impact for Bayfield County is roughly \$210,000 but the indirect impact is projected to be over \$900,000 due to lower sale rates and reduced prices paid across all species and products. Likewise, Washburn County is predicting over \$700,000 in receipts lost annually while only \$192,000 of that is from Verso. Furthermore, the multiplied value/impact on the greater forest products industry (loggers, truckers, community businesses, etc.) is staggering.

As Mayor of the City of Wisconsin Rapids, I wish to be registered as supporting SB 369, which would support a cooperative entity based in Northern Wisconsin in their objective of purchasing the Verso Paper Mill and putting it back into operation.

The closure of the Verso Paper Mill last July created an economic shock in the city of Wisconsin Rapids and the surrounding region. The Verso Paper Mill was the largest employer within Wisconsin Rapids and employed over 900 people, with most of those jobs lost after the closure. Area businesses that serve the mill will account for an additional 580 jobs lost due to the closure. The impact grows when you look at the regional and statewide impacts of this closure. Regionally, the closure is estimated to impact 1,931 jobs; with an estimated impact of 2,686 jobs statewide. These job losses relate to lost earnings for Wisconsin's people and lost tax revenues for Wisconsin's cities.

The Verso Paper Mill also consumed one-quarter of the pulpwood cut annually in Wisconsin, advancing timber and transportation industries throughout the state, while making an important impact on Wisconsin forestry. Much of this forest land is also under management plans already on file with the DNR.

The closure of our city's paper mill will have a profound effect on our community, our region and our state. And SB 369 poses an opportunity to bring back jobs, while ensuring our paper professionals' expertise stays local. It is an opportunity for our paper mill to again be locally owned and operated. After the closure of the Wisconsin Rapids mill, there has been a huge disruption in the markets for round wood pulp. The existing supply of wood inventory and Verso trying to honor existing supplier contracts have caused a huge flood of wood fiber entering Michigan. This has led to the lessening or complete elimination of wood supply contracts and sales by Michigan producers.

Michigan's wood fiber supply industry has been forced into the same operational situations experienced by the wood industry suppliers and truckers in the State of Wisconsin. Some truckers have had to close down and producers have been shuttering operations because of there being no market opportunities to sell the wood. My name is Tim Walters and I live in Cornell, Wi. I support SB 369. My reasoning is that I am owner and president of Walters Brothers Lumber Mfg., Inc. I have two plants, one in Radisson, Wi.(Sawyer county) and the other in Holcombe, Wi.(Chippewa county). Together I employ approx. 45 people. The Verso plant in Wisconsin Rapids was a major purchaser of hardwood pulpwood from loggers throughout Wisconsin. The closing of that mill has been devastating to loggers throughout the state as most do not have adequate markets for their pulpwood. This has not only caused a problem for loggers but also for sawmills that need hardwood logs. Without pulpwood markets loggers are not cutting enough hardwood logs to satisfy the demand for sawmills in Wisconsin. This is causing a financial hardship on many sawmills and could lead to some going out of business as a result. The trickle down effect of the Verso mill closing falls far beyond the employees of Verso.

The papermill in Park Falls, Wi. has also been a player in purchasing pulpwood from loggers until recently. That mill also, up until the most recent owner, had been purchasing bark, sawdust and woodchips from area sawmills to supplement fuel for their boilers. There are not nearly enough businesses accepting wood residue in Wisconsin to keep sawmills, etc. able to produce at full capacity. Many of the companies that use sawmill residue have shut down in the last 15 years. I started shipping wood to Verso mill and In 1972, I rec'd my own contract and have shipped to them since, until the closing of their doors. In 2016, I incorporated my business and now have a daughter and grand sons in the business, making us a six generation loggers. Without Version and the Park Falls mill, we have no place to ship birch or ash and extremely limited places to ship pine. Without the ability to ship those species, we have no way of managing our forests correctly. Where we live it is too far to ship wood by truck to Ahlstrom Munksjo in Kaukauna, because of the rules and regulations in the trucking industry. The CN costs are too high, so shipping by rail isn't an cost effective option. My name is Robert Evan Wunrow of Nekoosa, and I support this bill.

I am proud to say that I am an I.B.E.W. Local #1147 Union Electrician at the (Legacy) Consolidated Wisconsin Rapids Paper Mill...currently known as the Verso Wisconsin Rapids Mill.

I, personally, have worked at the Wisconsin Rapids Mill since January 6, 2014, but have Family ties to the mill that date all of the way back to the year 1980. I have always wanted to work at the mill since I was a little kid, when my Mom would take me through the plant floor to show me around (as it was okay to do that back then).

The people of Wisconsin Rapids used to envy anyone who worked within the Mill walls. You actually WERE somebody. You were a part of a PROUD operation, and everyone in the mill was like your family. And through my own experience, and opinion, that unfortunately started to go downhill when the original owners of the mill, Consolidated, sold the entire empire in the year 2000. The original Consolidated Company was ALWAYS ahead of the industry curve. If there was a specific type of paper that was on the come-up, they were already working on figuring out where to fit it into their product mix in the mill. An example would be the last major construction project, #16 machine, which was aimed at making Paper for the "Digital Era." Basically, printer paper...in 1992.

The Wisconsin Rapids mill used to be THE Standard on HOW to make Paper. Other Companies LONGED for the success that Consolidated was able to produce at the Wisconsin Rapids Mill for over 100 years. But now, it's been well over 20 years since the last major upgrade, and some equipment maintenance has been neglected over the past 20 years...with some paper machine product lines demolished and removed.
