Good Morning Chair Stafsholt and committee members for holding this public hearing on SB 780 which is a bill I feel will benefit the state of Wisconsin.

Nationally known to be one of the best states to hunt, many people from out of state travel to partake in our state's great sporting traditions whether it be for bow or gun seasons. In this budget cycle we raised the fees for out-of-state gun hunting licenses to \$197.25. Since this change, I have heard from many of my constituents who have applauded the increase because they believe our wild game in this state have been undervalued for many years. However, when we raised this fee, we left out the crossbow and archery licenses. In order to create equitable license fees and to fix what I believe to have been an oversight in the budget, SB 780 raises out-of-state crossbow and archery hunting licenses from \$162.25 to \$197.25.

I want to thank Representative Pronschinske for introducing the companion bill in the Assembly and for the hard work he has done on this legislation. Thank you for your time today and for your consideration of this bill.

Hello Chairman Stafsholt and members of the Senate Committee on Sporting Heritage and Financial Institutions. I, along with Senator Romaine Quinn (R-25) are excited to talk about Senate Bill 780 (SB 780). This bill would raise the nonresident archer and crossbow hunting license fee. This past budget cycle, the nonresident deer hunting firearm license was raised to \$197.25, but nonresident archer and crossbow licenses stayed at \$162.25. SB 780 would increase these two licenses to \$197.25 to equal the amount that a nonresident deer hunting license is.

Wisconsin is a large hunting state for a lot of individuals. Our state obviously has a lot of hunters and outdoorsmen in it but what is unique about Wisconsin alone, is the amount of out-of-state hunters and outdoorsmen that come here during hunting season. This season is a large part of our state's tourism and it is important that we continue to benefit from this part of the year.

Wisconsin has a tradition with nonresident individuals and we are thankful for their continued appreciation in our hunting land but we want to make sure that they pay their fair share. In Illinois, it costs \$411.00 for a "Non-Resident Deer Combo Archery Permit OTC." In Minnesota, it costs \$185.00 for a "Non-Resident Deer Archery" license. In Michigan, it costs \$151.00 for a "Non-Resident Base License" and an additional \$20.00 for deer or an additional \$190.00 for a deer combo. This deer combo would include two deer licenses. Iowa has a non-resident hunting license of \$131.00 with an additional \$15.00 habitat fee.

Senator Quinn and I are very excited about this bill idea and we hope there will be an array of bipartisan support of this bill. We are eager to work alongside the DNR in making sure this bill gets passed into law and we are excited to do the continued hard work it takes to make this bill happen.

Deer hunting has always been a big portion of our state's economy and archery and crossbow hunting is a large portion of our state's economy. I have been working on a variety of sporting heritage and outdoorsmen bill this past year and this is an important to me. I am honored to work alongside Sen. Quinn and I believe we have a great idea here.

2023 Senate Bill 780 Nonresident Archer and Crossbow Hunting License Fees December 19, 2023

Good morning Chair Stafsholt, and members of the Committee. My name is Katherine Walker and I am the Customer and Outreach Services Policy Advisor for the Wisconsin Department of Natural Resources. Thank you for the opportunity to testify, for informational purposes, on Senate Bill 780 (SB 780), related to nonresident archer and crossbow hunting license fees.

Current law establishes a variety of hunting, trapping and fishing approvals and specifies fees that are, in general, lower for residents than nonresidents. Until July 6, 2023, the nonresident archer license and the nonresident crossbow license fees were each \$157.25 under the statutory fee schedule in Chapter 29 of the Wisconsin statutes. Both of these licenses are subject to a \$0.75 issuing fee and a \$2.00 wildlife damage surcharge, for a total of \$2.75 in fees. This brought the total amount owed to \$160.00 when a nonresident customer purchased either of these licenses.

Additionally, if a customer wishes to upgrade either their nonresident archer license or their nonresident crossbow license, customers can upgrade their current license to include the nonresident license they do not have as long as both licenses are issued in the same hunting season. Under Wis. Stat. § 29.563(2g)(b) and (d), this upgrade fee is statutorily set at \$2.25 plus a \$0.75 issuing fee, for a total amount owed by the customer at \$3.00.

Under 2023 Wisconsin Act 19 (effective July 7, 2023), both the nonresident archer license and the nonresident crossbow license fees were increased \$5.00 to \$162.25. This act did not alter the issuing fee or wildlife damage surcharge applied to these two licenses. With the \$0.75 issuing fee and the \$2.00 wildlife damage surcharge, the total amount paid by the customer for either nonresident license is currently \$165.00. This act did not alter the cost of the nonresident archer upgrade or the nonresident crossbow upgrade, which remains \$3.00.

For the license year 2023-2024 (as of November 26, 2023), the department sold 5,882 nonresident crossbow licenses and 9,638 nonresident archer licenses. The department also sold 3,199 nonresident crossbow license upgrades and 667 nonresident archer license upgrades.

Under the provisions of SB 780, both the nonresident archer license and the nonresident crossbow license fees will increase \$35.00 to \$197.25. This bill does not alter the current \$0.75 issuing fee or the \$2.00 wildlife damage surcharge applied to these two licenses. Given this, the total amount paid by a customer to purchase either a nonresident archer license or a nonresident crossbow license would increase to \$200.00 (which is consistent with the current fee cost of the nonresident gun deer hunting license). This act also does not alter the cost of the nonresident archer upgrade or the nonresident crossbow upgrade, which remains \$3.00.



The department will incur one-time costs of \$4,264.00 or less to make necessary changes to the GoWild licensing system, train both customer service representatives and retail license agents, and to update department web pages and hunting, trapping, and fishing regulations.

Finally, SB 780 does not include an effective date, which means if this bill is passed, its provisions would be effective one day after the relevant act's date of publication meaning not all non-residents would pay the same fee in the license year. The author could consider amending the bill to include an effective date of March 1<sup>st</sup> so the bill would be effective at the beginning of the new license year.
