








#### WMC Background

- Founded in 1911 in response to progressive era reforms
- State Chamber of Commerce and Manufacturers Association
- More than 3,700 members statewide employing 1/4<sup>th</sup> of the private sector workforce
- All sectors of economy, and businesses of all size

# Some History on Technical Colleges in Wisconsin

- WI was the first state to establish state support for technical and adult education (Ch. 616, Laws of 1911)
- WI was also the first state to establish apprenticeship agreements (Ch. 347, Laws of 1911)
- Over time, that evolved into the Technical College System that we have in WI today






# WMC Partnerships with Technical Colleges

 WTCS stimulates local economic development by providing the state with hands-on education that brings people and jobs together at incredibly high placement rates








# The Skills Gap in Wisconsin is Real

- WI employers continue to struggle finding qualified workers
- Gap between job demands and worker skills
- How do we know?
- We held focus groups in 54 communities with 300 manufacturers, tours of all 16 technical colleges by 1,200 business and education leaders and two statewide conferences

#### Fast Forward


- \$50 million for employee training grants and ending wait lists for in-demand technical college programs
- Labor Market Information System (LMIS) to connect workers and employers according to skills and job demands in a timely fashion

#### **Apprenticeship Reforms**

• \$1 million for tuition reimbursement and youth apprenticeship grants




### CEO Survey, July 2014

Employers are optimistic

- 96% believe WI is heading in the right direction
- 90% say state government is very or somewhat pro-business
- 71% believe WI will see moderate growth in next 6 months (65% in January)
- 56% of CEOs expect to hire in the next 6 months






### CEO Survey, July 2014

Optimism doesn't fix skills gap or create jobs

- 53% having trouble finding workers
  - 72% lack of qualified workers
  - 20% poor work ethic
  - 16% generous entitlement programs
  - 11% substance abuse
- High taxes, burdensome federal laws and regulations work against hiring






#### **Areas of Concern**

- Keeping programs in line with the needs of employers
- Ensuring graduates are ready to work
- Overcoming the outdated stigma placed on technical education and manufacturing
- Keep mission focused on local economic development, partnering with local manufacturers to continually improve programs and class offerings to meet the goals mentioned above






#### **Major State and Local Taxes**

WI taxes rank high as a percentage of personal income

- Property Tax: #11 among states
- Income Tax: #11
- Sales Tax: #36
- Overall Tax Burden: #11

## **Property Tax**

- Largest state or local tax paid
  - \$10.3 billion in 2011/12
- Levied by multiple levels of government
- Challenging for voters to assign responsibility for property tax changes








## **Property Tax - WTCS**

- Traditional "levy limit" for district boards replaced by "revenue limit"
- Allow revenue growth equal to the larger of:
  - 0%; or
  - Growth from net new construction
- Infusion of \$406 million in state aid in Dec 2014






#### Referenda for Capital Expenditures

- \$1.5 million cap before referendum
  - Increased from \$1 million (2009)
- Exceptions
  - Student housing, if levy, state aid, or tuition funds are not used (2011)
  - \$2.5 million cap if equal amount of federal funds (2013)
- Further tweaks to s. 38.15?






#### Referenda for Capital Expenditures

- Referenda Approved
  - Madison Area Nov 2010
    - \$133 million bond
    - 63% approval
  - Fox Valley Apr 2012
    - \$66.5 million bond
    - 65% approval






## **Cost Comparison**

- Lumina Foundation for Education
   "Trends in College Spending 1999-2009"
  - Shows Wisconsin had highest state subsidy for community colleges
- Fair comparison?

#### **District Boundaries**

- Difficult to adjust boundaries
  - Germantown situation
- If no property tax levied, allow tech colleges to compete regardless of geographic boundaries?
