

NREMT STATES




Blue states represent those that require NREMT registration for licensure.








HOW APPLICANTS APPLY FOR PERSONNEL LICENSES












RENEWAL APPLICATION





LENGTH OF LICENSE BEFORE RENEWAL


Renewal Length (in years)




