# State of Wisconsin Interagency Council on Homelessness

## 2020 Annual Report to the Governor and Legislature

Prepared by Michael Basford, Director  
Submitted December 31, 2020

At the beginning of 2020, homelessness in Wisconsin remained a challenging issue throughout all areas of the state. The annual point-in-time count in January recorded 4,515 people in emergency shelters, transitional housing, Safe Havens or unsheltered. These numbers included 338 veterans, 611 chronically homeless (defined as a single individual, or head of household, with a disabling condition who has either experienced homelessness for longer than a year, during which time the individual may have lived in a shelter, Safe Haven, or a place not meant for human habitation or experienced homelessness four or more times in the last three years), and 324 people who were unsheltered. The Department of Public Instruction reported 18,349 homeless students (defined as children and youths as those who lack a fixed, regular, and adequate nighttime residence) in Wisconsin schools.

Most of these numbers reflected very slight decreases from the previous year (a slight increase in the number of unsheltered homeless persons being an exception), but also showed the need for better efforts and more resources to house the most vulnerable of our state.

The Coronavirus (COVID-19) pandemic presented unprecedented challenges for state agencies and community systems that serve the homeless. Most of the Council's energy and attention this year was devoted to assisting in the response to these challenges.

## **Response to COVID-19**

COVID-19 created unprecedented strains on community homelessness systems throughout the state. To adhere to U.S. Centers for Disease Control Prevention guidelines for social distancing in emergency shelters and reduction of staff and volunteers, most shelters had to dramatically reduce their capacities, stop taking new clients, or close entirely in response to COVID-19. Additionally, many people who were doubled-up in housing needed to leave where they were staying, and many homeless people declined to seek emergency shelter out of fear of contracting coronavirus. These factors, and other social conditions, resulted in a surge in unsheltered homelessness in Wisconsin.

Were it not for the absolutely heroic efforts by agencies and communities around the state to implement creative responses to this crisis, untold numbers of homeless people would have become ill or have succumbed to COVID-19. At significant expense, many agencies and communities stood up non-congregate sheltering in alternate locations such as hotels and motels. Continuum of Care and other agencies recognized the challenges very early in this crisis and worked quickly to adapt operations to implement social distancing and other methods to prevent spread.

State government response included manifold actions to help homeless people and to keep people in housing and out of the homelessness system during the ensuing economic downturn. They included:

- On March 26th, Governor Evers announced a 60-day moratorium on rental evictions and housing foreclosures - which provided temporary relief for Wisconsinites affected by the economic downturn.
- As that moratorium ended, Governor Evers announced a new program, the Wisconsin Rental Assistance Program administered through the Department of Administration and local CAP agencies, that provided over \$28 million in CARES ACT funds for up to \$3,000 per household to help people avoid evictions. At the close of the program, over 14,200 households were assisted through WRAP.
- On May 20<sup>th</sup>, Governor Evers also announced the creation of the Food Security Initiative – which provided \$15 million in CARES ACT funds for food banks and non-profits to assist people experiencing food insecurity.
- The Department of Administration’s Division of Energy, Housing and Community Resources also has worked to distribute HUD Emergency Solutions Grant funding provided by the CARES ACT. The first round of \$12.7 million was allocated in October and a second round of \$19.7 million is on schedule to be allocated in early 2021.

As has happened in previous years, we have experienced the loss of homeless people who have died outside in Wisconsin. The surge in unsheltered homelessness as a result of COVID-19 is cause for alarm and concern and highlight the need to return people to housing as quickly as possible.

Included in the thousands of people in Wisconsin who died as a result of COVID-19 were two people whose lives were dedicated to helping care for the homeless and whose losses are being profoundly felt in the communities in which they served. Bob Quam was the Director of Development for the Stevens Point Salvation Army shelter. Bob worked tirelessly to assist people who were struggling with addictions and people who were looking to transition into permanent housing. He died of COVID-19 in September. Billy Ross was a former client and very well-regarded staff member at the Milwaukee Rescue Mission. Billy’s story was one of the transformational powers many agencies have in the lives of vulnerable people they serve. He died of COVID-19 in April. These are two of the too-many reminders of the toll COVID-19 is having on our communities and supports.

## **Hand and a Home Update**

As we entered 2020, a goal for the year was to draft an update for the “Hand and a Home” state homelessness plan. The goals for the plan update this year included the following:

### ***1) Adding a much-needed section on addressing racial disparities in the homelessness systems and housing markets in Wisconsin.***

We face an urgent need to address the issue of racial disparities in homelessness systems and housing markets. Decades of redlining, housing and job discrimination, and other factors have led to the fact that while Wisconsin’s population is 83 percent white, Black, Indigenous and People of Color make up a majority of those served by the homelessness system. If we are to end homelessness as we know it in Wisconsin, we will need to push for solutions that advance racial equity and increase housing opportunities for BIPOC Wisconsinites. The facts are indisputable, and we can easily connect the dots between inequities and homelessness.

To address this need, a Racial Equity workgroup was recruited and has been regularly meeting to learn more details and review the current plan. The members of the workgroup are:

**2) Updating the “Performance Metrics” section to include details on responsibilities for implementing strategies, timelines, and (where possible) measurable goals. And,**

**3) Evaluating any themes, strategies, and goals for editing, augmenting or removing.**

For these, we devoted time at three workgroup meetings to review the current plan and launched a public comment page to take input. The COVID-19 response needs pushed the plan update schedule back several months, but as we end 2020 work is happening on the update. We look forward to having the update available for Council approval by no later than the end of 2<sup>nd</sup> Quarter in 2021.

## Director’s Activities

*From Michael Basford, Interagency Council on Homelessness Director:*

“In the 2019 Interagency Council Annual Report, I highlighted three duties for this position I developed in addition to the statutory requirements. Those duties were:

- ***Establish a relationship with communities and organizations around Wisconsin to understand how homelessness affects every area of Wisconsin, to learn the details of community responses to homelessness, and to provide whatever assistance I can to help these communities fight homelessness;***
- ***Identify areas of policy for focusing state resources; and***
- ***Serve as a conduit between levels of government.***

How those duties were realized in 2020 look radically different than how they looked and what they meant in 2019. Many of my activities as part of the COVID-19 response involved providing technical support to agencies and communities to help provide care for homeless people affected by the pandemic.

I created weekly check-ins with the Continuum of Care leads/DOA-DEHCR/HUD as well as weekly meetings with the State Emergency Operations Center Emergency Support Function 6 Team to monitor how the pandemic is affecting operations with homelessness programs around the state, provide assistance in PPE distribution for homeless services agencies, and connect information and data on non-congregate sheltering in communities with FEMA.

I started working in isolation from home on March 10<sup>th</sup>. Prior to that, the following was where I visited:

In May and June, I assisted the Department of Public Instruction's Education for Homeless Children and Youth team with their evaluations of applications for the 2020-2023 EHCY grants.

I have been working and will continue to work with the State Medicaid Learning Collaborative to develop and expand innovative state strategies to provide housing-related supports and activities under Medicaid for individuals with substance use disorders. I look forward to these efforts providing resources to increase supportive services for the homeless and housing-insecure.

I have also been meeting with Governor's office and Budget office staff to develop and review ideas for the upcoming biennial budget. One thing we must not lose sight of as we move through our COVID-19 responses is that there are many unmet needs for programming and funding to fight homelessness - including case management, homelessness diversion, housing navigation, and support for landlords to bring more affordable units online.

In 2021, I plan to continue to work with national agencies like the National Alliance to End Homelessness, National Low-Income Housing Coalition, Corporation for Supportive Housing, Urban Institute and others to explore options to help facilitate development for low-income affordable housing – the availability of which is our largest challenge to our efforts to move people from homelessness into housing.”

## **Looking forward**

The Interagency Council on Homelessness looks forward to the following in 2021:

- 1) Completing the update for the “Hand and a Home” plan.
- 2) Continuing our COVID-19 responses to help our most vulnerable in Wisconsin – including supporting solutions for more sheltering and housing and advocating for distribution of vaccines for the homeless to protect them and agency workers to improve system capacity.
- 3) Providing resources through the upcoming biennial budget to assist the homeless.
