Dear Mr. Renk and Mr. Fuller:

This report is transmitted as required by s. 20.002(11)(f), Wisconsin Statutes, (for distribution to the appropriate standing committees under s. 13.172(3), Wisconsin Statutes) and confirms that the Department of Administration has found it necessary to exercise the "temporary reallocation of balances" authority provided by this section in order to meet payment responsibilities and cover resulting negative cash balances during the month of November 2020.

On November 1, 2020, the **Medical Assistance Trust Fund** cash balance closed at a negative \$193.28 million (its intramonth low). The cash balance was negative until November 19, 2020, when it closed at a positive \$44.67 million.

On November 1, 2020, the **Worker's Compensation Fund** cash balance closed at a negative \$1.41 million. The cash balance was negative through November 30, 2020, when it closed at a negative \$2.30 million (its intramonth low).

On November 13, 2020, the **Police and Fire Protection Fund** cash balance closed at a negative \$36.09 million (its intramonth low). The cash balance was negative through November 30, 2020, when it closed at a negative \$31.57 million.

On November 25, 2020, the **Environmental Improvement Fund** cash balance closed at a negative \$3.81 million (its intramonth low). The cash balance was negative until November 27, 2020, when it closed at a positive \$3.35 million.


On November 23, 2020, the **Veterans Trust Fund** cash balance closed at a negative \$45 thousand. The cash balance was negative through November 30, 2020, when it closed at a negative \$228 thousand (its intramonth low).

The Medical Assistance Trust Fund, Worker's Compensation Fund, Police and Fire Protection Fund, Environmental Improvement Fund and Veterans Trust Fund shortfalls were due to the difference in the timing of revenues and expenditures. The shortfalls were not in excess of the statutory interfund borrowing limitations and did not exceed the balances of the funds available for interfund borrowing.

The distribution of interest earnings to investment pool participants is based on the average daily balance in the pool and each fund's share. Therefore, the monthly calculation by the State Controller's Office will automatically reflect the use of these temporary reallocations of balance authority, and as a result, the funds requiring the use of the authority will effectively bear the interest cost.
