Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On November 9, 2019, the agency received a report regarding a 1-year-old infant pronounced deceased in his home. Law Enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant; toxicology results were negative. No criminal charges have been filed in this case and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by the mother and father. The Medical Examiner's Office noted no signs of trauma to the infant. The agency determined the infant's sibling safe and the infant's sibling remained with the mother. The family was referred to community-based services and the agency closed the case upon completion of the Initial Assessment.

At the time of the incident, the agency was assessing a CPS Report received on September 20, 2019. A protective plan was implemented with the family and the family was referred to community-based services. The last contact by the agency was a face-to-face contact with the infant, his 3-year-old sibling and his mother on October 11, 2019.

On September 20, 2019, the agency screened-in a CPS Report alleging neglect to the infant by the mother. The infant died during the assessment period and an additional report was made to the agency regarding the infant's death on November 9, 2019. An assessment of the allegation was completed by the agency and the initial allegation of neglect was unsubstantiated.

On June 26, 2018, the agency screened-in a CPS Report alleging neglect to the infant's now 3-year-old infant by the mother. An assessment was completed by the agency and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On December 2, 2019, the agency received a report regarding a 5-month-old infant pronounced deceased in her home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant. The official cause of the infant's death was undetermined; toxicology results are pending. No criminal charges were filed and the case was closed.
