Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On December 27, 2019, the agency received a report regarding a four-year-old child who was brought to the hospital unresponsive with multiple injuries and was subsequently pronounced deceased on the same day. The Medical Examiner's Office determined the injuries were non-accidental and medical personnel noted signs of blunt force trauma. Law enforcement was contacted and initiated a criminal investigation. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse and neglect to the child by the mother's significant other. The Medical Examiner's Office determined the injuries were non-accidental and medical personnel noted signs of blunt force trauma. The child's siblings were deemed unsafe and taken into Temporary Physical Custody. The child's 5-year-old sibling was placed with relatives, and his 9-month-old half-sibling was placed in a non-relative licensed foster home. Petitions for Protection or Services were filed and the case remained open to provide ongoing case management services.

On April 23, 2019, the agency screened-in a Services Report. The family was accepted for services.

On January 21, 2019, another agency screened-in a CPS Report alleging physical abuse and neglect to the child's father's significant other's now 3-year-old child by the deceased child's father. An assessment was completed by the agency and the allegations of physical abuse and neglect were substantiated. A Petition for Protection or Services was filed on or about February 4, 2019 and the case remains open to provide ongoing case management services.
