The first quarter meeting of the Joint Committee on Finance under s. 13.10 is scheduled for Wednesday, September 18, 2013, at 1:00 p.m. in Room 412 East, State Capitol.

The Governor's recommendations on the requests and State Budget Office analyses of them will be distributed to the members on or before September 16, 2013, along with the formal agenda. The Legislative Fiscal Bureau will distribute its own analyses of the requests.

The following is a summary of the items in the order that they will be heard on September 18, 2013.
