**ASSEMBLY AMENDMENT 7,
TO SENATE BILL 21**

July 8, 2015 – Offered by Representatives POPE, GENRICH, SINICKI and CONSIDINE.

1 At the locations indicated, amend the bill, as shown by senate substitute
2 amendment 1, as follows:

3 **1.** At the appropriate places, insert all of the following:

4 “**SECTION 1.** 118.60 (2) (a) 10. of the statutes is created to read:

5 118.60 (2) (a) 10. The private school is located in this state.

6 **SECTION 2.** 118.60 (2) (d) of the statutes is created to read:

7 118.60 (2) (d) No more than 49 percent of a private school’s enrollment may
8 consist of pupils attending the private school under this section.

3 2. For an incoming choice pupil, upon receipt from the pupil’s parent or
4 guardian of proof of the pupil’s enrollment in the private school during a school term,
5 the state superintendent shall pay to the private school in which the pupil is enrolled
6 on behalf of the pupil’s parent or guardian, from the appropriation under s. 20.255
7 (2) (fr), an amount determined under s. 118.51 (16) (a) 3. b. for that school year.

3 program is guilty of a Class A misdemeanor.

4 (3) No person may do any of the following:

5 (a) Having knowledge of an event affecting the person’s eligibility to participate
6 in a parental choice program, conceal or fail to disclose that event with an intent to
7 fraudulently participate in a parental choice program.

8 (b) Receive a payment under a parental choice program and use the funding
9 for purposes that are not authorized under the parental choice program.

10 (c) Whoever violates par. (a) or (b) is subject to the following penalties:

11 1. If the value of the payment that is obtained as the result of the violation is
12 more than \$5,000 but does not exceed \$10,000, a Class H felony.

13 2. If the value of the payment that is obtained as the result of the violation is
14 more than \$10,000, a Class G felony.

15 (4) Whoever makes any statement in a written application to participate in a
16 parental choice program is considered to have made an admission as to the existence,
17 correctness, or validity of any fact stated. Such a statement is prima facie evidence
18 against the person who made it in any complaint, information, or indictment, or in
19 any action brought for enforcement of any provision of this section.
