**ASSEMBLY AMENDMENT 27,
TO SENATE BILL 21**

July 8, 2015 – Offered by Representatives HEBL, SHANKLAND, MASON, MILROY and SPREITZER.

1 At the locations indicated, amend the bill, as shown by senate substitute
2 amendment 1, as follows:

3 **1.** At the appropriate places, insert all of the following:

4 “**SECTION 1.** 49.45 (23) (a) of the statutes is amended to read:

5 49.45 (23) (a) The department shall request a waiver from the secretary of the
6 federal department of health and human services to permit the department to
7 conduct a demonstration project to provide health care coverage to adults who are
8 under the age of 65, who have family incomes not to exceed ~~100~~ 133 percent of the
9 poverty line ~~before application of the 5 percent income disregard under 42 CFR~~
10 ~~435.603 (d), except as provided in s. 49.471 (4g),~~ and who are not otherwise eligible
11 for medical assistance under this subchapter, the Badger Care health care program
12 under s. 49.665, or Medicare under 42 USC 1395 et seq.

13 **SECTION 2.** 49.471 (1) (cr) of the statutes is created to read:

1 49.471 (1) (cr) “Enhanced federal medical assistance percentage” means a
2 federal medical assistance percentage described under 42 USC 1396d (y) or (z).

3 **SECTION 3.** 49.471 (4) (a) 4. b. of the statutes is amended to read:

4 49.471 (4) (a) 4. b. The Except as provided in sub. (4g), the individual’s family
5 income does not exceed ~~100~~ 133 percent of the poverty line ~~before application of the~~
6 ~~5 percent income disregard under 42 CFR 435.603 (d).~~

7 **SECTION 4.** 49.471 (4g) of the statutes is created to read:

8 49.471 (4g) **MEDICAID EXPANSION; FEDERAL MEDICAL ASSISTANCE PERCENTAGE.** (a)
9 For services provided to individuals described under sub. (4) (a) 4. and s. 49.45 (23),
10 the department shall comply with all federal requirements to qualify for the highest
11 available enhanced federal medical assistance percentage. The department shall
12 submit any amendment to the state medical assistance plan, request for a waiver of
13 federal Medicaid law, or other approval required by the federal government to
14 provide services to the individuals described under sub. (4) (a) 4. and s. 49.45 (23) and
15 qualify for the highest available enhanced federal medical assistance percentage.

16 (b) If the department does not qualify for an enhanced federal medical
17 assistance percentage, or if the enhanced federal medical assistance percentage
18 obtained by the department is lower than printed in federal law as of July 1, 2013,
19 for individuals eligible under sub. (4) (a) 4. or s. 49.45 (23), the department shall
20 submit to the joint committee on finance a fiscal analysis comparing the cost to
21 maintain coverage for adults who are not pregnant and not elderly at up to 133
22 percent of the poverty line to the cost of limiting eligibility to those adults with family
23 incomes up to 100 percent of the poverty line. The department may reduce income
24 eligibility for adults who are not pregnant and not elderly from up to 133 percent of

1 the poverty line to up to 100 percent of the poverty line only if this reduction in income
2 eligibility levels is approved by the joint committee on finance.”.

3 **2.** Page 95, line 23: increase the dollar amount for fiscal year 2015–16 by
4 \$140,900 and increase the dollar amount for fiscal year 2016–17 by \$140,900 for the
5 purpose for which the appropriation is made.

6 **3.** Page 101, line 7: increase the dollar amount for fiscal year 2015–16 by
7 \$671,300 and increase the dollar amount for fiscal year 2016–17 by \$671,300 for the
8 purpose for which the appropriation is made.

9 **4.** Page 131, line 14: increase the dollar amount for fiscal year 2015–16 by
10 \$4,668,800 and increase the dollar amount for fiscal year 2016–17 by \$4,668,800 for
11 the purpose of increasing the authorized FTE positions for the department of natural
12 resources by 44.68 GPR state parks and state recreation areas positions.

13 **5.** Page 134, line 10: increase the dollar amount for fiscal year 2015–16 by
14 \$128,100 and increase the dollar amount for fiscal year 2016–17 by \$128,100, and
15 adjust the NET APPROPRIATION totals accordingly, for the purpose of increasing
16 the authorized FTE positions for the department of natural resources by 1.75 SEG
17 wildlife management positions.

18 **6.** Page 134, line 11: increase the dollar amount for fiscal year 2015–16 by
19 \$80,700 and increase the dollar amount for fiscal year 2016–17 by \$80,700, and
20 adjust the NET APPROPRIATION totals accordingly, for the purpose of increasing
21 the authorized FTE positions for the department of natural resources by 1.0 SEG
22 educator position.

23 **7.** Page 134, line 12: increase the dollar amount for fiscal year 2015–16 by
24 \$242,700 and increase the dollar amount for fiscal year 2016–17 by \$242,700, and

1 adjust the NET APPROPRIATION totals accordingly, for the purpose of increasing
2 the authorized FTE positions for the department of natural resources by 3.0 SEG
3 educator positions.

4 **8.** Page 134, line 12: decrease the dollar amount for fiscal year 2015–16 by
5 \$3,224,500 and decrease the dollar amount for fiscal year 2016–17 by \$3,224,500,
6 and adjust the NET APPROPRIATION totals accordingly, for the purpose of
7 decreasing the authorized FTE positions for the department of natural resources by
8 44.68 SEG state parks and state recreation areas positions.

9 **9.** Page 137, line 17: increase the dollar amount for fiscal year 2015–16 by
10 \$79,400 and increase the dollar amount for fiscal year 2016–17 by \$79,400 for the
11 purpose of increasing the authorized FTE positions for the department of natural
12 resources by 1.0 SEG educator position.

13 **10.** Page 139, line 15: increase the dollar amount for fiscal year 2015–16 by
14 \$103,800 and increase the dollar amount for fiscal year 2016–17 by \$103,800 for the
15 purpose of increasing the authorized FTE positions for the department of natural
16 resources by 1.25 PR science services positions.

17 **11.** Page 140, line 9: increase the dollar amount for fiscal year 2015–16 by
18 \$50,400 and increase the dollar amount for fiscal year 2016–17 by \$50,400 for the
19 purpose of increasing the authorized FTE positions for the department of natural
20 resources by 0.5 SEG science services position.

21 **12.** Page 140, line 11: increase the dollar amount for fiscal year 2015–16 by
22 \$793,000 and increase the dollar amount for fiscal year 2016–17 by \$793,000 for the
23 purpose of increasing the authorized FTE positions for the department of natural
24 resources by 7.4 SEG science services positions.

1 **13.** Page 140, line 11: increase the dollar amount for fiscal year 2015–16 by
2 \$163,900 and increase the dollar amount for fiscal year 2016–17 by \$163,900 for the
3 purpose of increasing the authorized FTE positions for the department of natural
4 resources by 2.25 SEG law enforcement positions.

5 **14.** Page 144, line 1: increase the dollar amount for fiscal year 2015–16 by
6 \$426,100 and increase the dollar amount for fiscal year 2016–17 by \$426,100, and
7 adjust the NET APPROPRIATIONS totals accordingly, for the purpose of increasing
8 the authorized FTE positions for the department of natural resources by 5.75 SEG
9 fisheries management positions.

10 **15.** Page 144, line 11: increase the dollar amount for fiscal year 2015–16 by
11 \$21,200 and increase the dollar amount for fiscal year 2016–17 by \$21,200 for the
12 purpose of increasing the authorized FTE positions for the department of natural
13 resources by 0.25 SEG educator position.

14 **16.** Page 150, line 9: increase the dollar amount for fiscal year 2015–16 by
15 \$400,000 for the purpose for which the appropriation is made.

16 **17.** Page 156, line 19: increase the dollar amount for fiscal year 2015–16 by
17 \$259,300 and increase the dollar amount for fiscal year 2016–17 by \$259,300 for the
18 purpose of increasing the authorized FTE positions for the department of natural
19 resources by 3.1 SEG administration positions.

20 **18.** Page 158, line 23: increase the dollar amount for fiscal year 2015–16 by
21 \$220,000 and increase the dollar amount for fiscal year 2016–2017 by \$220,000 for
22 the purpose of increasing the authorized FTE positions for the department of natural
23 resources by 3.0 SEG educator positions.

1 **19.** Page 158, line 23: increase the dollar amount for fiscal year 2015–16 by
2 \$27,700 and increase the dollar amount for fiscal year 2016–17 by \$27,700 for the
3 purpose of increasing the authorized FTE positions for the department of natural
4 resources by 0.5 SEG customer assistance and employee services position.

5 **20.** Page 195, line 7: decrease the dollar amount for fiscal year 2015–16 by
6 \$113,100,000 and decrease the dollar amount for fiscal year 2016–17 by
7 \$247,400,000 for the purpose of providing Medical Assistance to certain adults with
8 incomes up to 133 percent of the federal poverty line.

9 **21.** Page 292, line 24: delete the material beginning with that line and ending
10 with page 293, line 3.

11 **22.** Page 304, line 1: delete lines 1 to 6 and substitute:

12 “20.370 (7) (ad) *Land sales — principal repayment.* All moneys received from
13 the proceeds from the sale of land and property under s. 23.145, 2013 stats., to
14 reimburse s. 20.866 (1) (u) for the payment of principal on outstanding public debt
15 incurred under the Warren Knowles–Gaylord Nelson stewardship 2000 program
16 under s. 23.0917 and to make payments under an agreement or ancillary
17 arrangement entered into under s. 18.06 (8) (a).”.

18 **23.** Page 304, line 23: delete the material beginning with that line and ending
19 with page 305, line 3.

20 **24.** Page 350, line 18: delete lines 18 and 19 and substitute “The state may
21 contract public debt in an amount not to exceed \$1,134,500,000 for this program.
22 Except as provided in s. 23.0917 (4g) (b), (4m) (k).”.

1 **25.** Page 351, line 2: delete lines 2 to 4 and substitute “2014–15, may not
2 exceed \$54,500,000 in fiscal year 2015–16, and may not exceed \$50,000,000 in each
3 fiscal year beginning with fiscal year 2016–17 and ending with fiscal year 2019–20.”.

4 **26.** Page 352, line 15: after that line insert:

5 “**SECTION 871r.** 20.866 (2) (ti) of the statutes is amended to read:

6 20.866 (2) (ti) *Natural resources; contaminated sediment removal.* From the
7 capital improvement fund, a sum sufficient for the department of natural resources
8 to fund removal of contaminated sediment under s. 281.87. The state may contract
9 public debt in an amount not to exceed ~~\$32,000,000~~ \$37,000,000 for this purpose.”.

10 **27.** Page 371, line 7: delete the material beginning with that line and ending
11 with page 372, line 19.

12 **28.** Page 373, line 1: delete lines 1 to 12.

13 **29.** Page 373, line 14: delete lines 14 to 19 and substitute:

14 “23.0917 (5g) (a) Except as provided in ~~par. pars.~~ (b) and (c), if for a given fiscal
15 year, the department obligates an amount from the moneys appropriated under s.
16 20.866 (2) (ta) for a subprogram under sub. (3) or (4) that is less than the annual
17 bonding authority under that subprogram for that given fiscal year, the department
18 may not obligate the unobligated amount in subsequent fiscal years. This subsection
19 applies beginning with fiscal year 2011–12 and ending with fiscal year 2019–20
20 2014–15.

21 **SECTION 961i.** 23.0917 (5g) (b) of the statutes is amended to read:

22 23.0917 (5g) (b) If in ~~a given fiscal year beginning with~~ fiscal year 2013–14 or
23 2014–15 the amount that the department obligates from the moneys appropriated
24 under s. 20.866 (2) (ta) to provide grants to nonprofit conservation organizations

1 under s. 23.096 is less than the amount set aside for that purpose under sub. (3) (br)
2 in that fiscal year, the department may obligate the unobligated amount in the next
3 fiscal year but only for the purpose of awarding a grant under s. 23.0953 to a county
4 for the acquisition of land for a county forest under s. 28.11.”.

5 **30.** Page 374, line 18: after that line insert:

6 “SECTION 961v. 23.0917 (8) (f) 2. of the statutes is amended to read:

7 23.0917 (8) (f) 2. ~~Beginning with~~ In fiscal year years 2013–14 and 2014–15, of
8 the amount set aside for a given fiscal year under sub. (3) (bt), not more than
9 one–third of that amount may be obligated for the purpose of the acquisition of land
10 by the department.”.

11 **31.** Page 375, line 4: delete the material beginning with that line and ending
12 with page 376, line 14 and substitute:

13 “SECTION 980c. 23.145 of the statutes is repealed.

14 SECTION 980e. 23.15 (6) of the statutes is amended to read:

15 23.15 (6) This section does not apply to property that is authorized to be sold
16 under s. 16.848 ~~or that is required to be sold or offered for sale under s. 23.145.~~”.

17 **32.** Page 378, line 15: after that line insert:

18 “SECTION 1004g. 24.553 of the statutes is created to read:

19 **24.553 Climate change discussions.** The board may not prohibit any
20 employee of the board from discussing, or engaging in work related to, the issue of
21 climate change.”.

23 “SECTION 1032r. 27.01 (3m) of the statutes is created to read:

1 27.01 **(3m)** PROHIBITED SALES. The department may not sell state park land to
2 an organization operated for profit and may not sell the naming rights to any state
3 park to an organization operated for profit.”.

5 increased by 1.0 SEG educator position to be funded from the appropriation under
6 section 20.370 (9) (iq) of the statutes, as affected by this act.

7 (d) The authorized FTE positions for the department of natural resources are
8 increased by 9.25 FED science services positions to be funded from the appropriation
9 under section 20.370 (3) (my) of the statutes, as affected by this act.”.
